TRANSPORTATION COMMISSION UPDATE - TIM HULL

Hull - we had some discussion of the Winchell/Brockman sidewalk project as well as pavement condition, though the bulk of the discussion was regarding the proposed widening of the East Medical Center Drive bridge at the U-M hospital. Many commissioners pushed back at that due to not wanting to add additional car lanes (particularly general-purpose car lanes as opposed to bus or HOV lanes), and the commission will be discussing this at tonight's meeting as well. Aside from that it was mostly routine status updates.
