H CM Nelson. I think if you really want to be transparent, you need to share the data and the methodology. For example, does a vote with the majority in favor of the consent agenda count the same as a vote with the majority on a contentious issue like censuring CM Hayner? Did you even include consent agenda votes? Is that one vote or 10 votes, one for each CA item? How do you count an abstention or an absence? How do you handle a yes vote on a first reading and a no vote on a second reading? How are votes on amendments counted?

Sharing your dataset and detailing your methods are standard practice when publishing statistical analysis. Please consider adding these details to your blog.
