FOREWORD

From Commission Chair Molly Kleinman

The last year remained extraordinarily challenging for our community as the COVID-19 pandemic raged on. We would be remiss to reflect on the work of the Transportation Commission in 2021 without first acknowledging the ongoing pain of the pandemic, and the losses of so many lives and livelihoods both in Ann Arbor and around the world. Likewise I want to recognize the parallel public health crisis of increasing traffic violence and driver aggression, along with a rise in deaths of vulnerable road users across the U.S. Every life is precious. Let us do everything we can to keep each other safe.

The Transportation Commission has continued to work effectively with City Council and staff to help move Ann Arbor toward our transportation safety, inclusion, accessibility, and Vision Zero goals. The Commission plays an important part in Ann Arbor's planning and policy process, and Commissioners bring a wide range of expertise and experience to help the city address transportation challenges, decision making, and future planning. Details of our work are contained in this report, and a few highlights are below.

Personal Mobility Ordinance

Members of the Transportation Commission worked with city staff for several years to develop updates to the relevant city ordinance that would expand the types of vehicle permitted in bike lanes and on sidewalks. The new ordinance uses flexible language that accommodates scooters and ebikes, as well as other types of micromobility device that roll through in the future.

Winter Sidewalk Maintenance

Sidewalks are a key part of our transportation infrastructure. Building on the work of the Pedestrian Safety and Access Task Force that precedes us, this year the Transportation Commission provided input and recommendations for Ann Arbor to centralize and improve its approach to ensuring that sidewalks are clear and accessible all year round.

Healthy Streets

In the second year of the Covid-19 pandemic, Ann Arbor put forward a revised version of the Healthy Streets program started in the summer of 2020. This year the program focused on road reconfigurations that could be permanent or could serve as pilots for future permanent changes. Members of the Transportation Commission provided feedback and recommendations to City Council encouraging the adoption of Healthy Streets, gave suggestions for improving street configurations, and reviewed preliminary data on the program. Despite unfortunate delays in implementation of the program, these early data already suggest that the 2021 Healthy Streets program resulted in improved safety for all road users.

FOREWORD CONTINUED

It has been an honor and a pleasure to serve as Transportation Commission chair this year. Though our city and country are still in the thick of the pandemic, with many challenges yet to come, I look forward to continuing to serve out my term as chair, and to work in partnership with City Council to build back better and safer for all road users.

Resolution to Request that the City Administrator Determine the Cost and Feasibility of Supplemental Snow and Ice Removal of our Pedestrian Infrastructure to Improve Pedestrian Safety within the DDA Boundaries

A motion was made by Feldt, seconded by Hautamaki, that the Transportation Commission believes that R-21-084 fulfills the goals of the resolution passed by the Transportation Commission February 17, 2021, and therefore the Transportation Commission believes that no further action on 2/16/21 Resolution to Determine Cost and Feasibility of Supplemental Snow and Ice Removal is needed from City Council at this time. On a unanimous voice vote, the Chair declares the motion carried.

January 20

Transportation Commission 7th Street Evaluation Committee Recommendations

The Transportation Commission recommended that Council provide direction and budget for staff to implement the following recommendations:

- 1. Collect systematic data for arterial streets, make data-driven recommendations, and pursue street improvements in locations that are likely to have a large impact.
- 2. Broaden the application of existing quick build/paint-and-post tools to mediate speed on arterial streets.
- 3. Develop a Major Street Calming initiative
- 4. Explore means of local driver education.
- 5. Explore conceptual level design for All Ages and Abilities bike facility along 7th St. Present design to the community and develop further if there is public support.

Process Improvements learned from the 7th Street Speed Calming Effort

- 1. Limit ad hoc responses to resident complaints
- 2. Establish formal projects with dedicated budget and resources.
- 3. Develop clear goals that can be evaluated, and schedule the evaluation timeline at the beginning of the project: "beginning with the end in mind."
- 4. Empower and retain city staff so that there is continuity of planning and engagement.
- 5. Develop community engagement/public education strategies to promote education and awareness

The 7th Street Process Recommendations were provided as a communication item to City Council on February 16, 2021

May 19

Amendments to Proposed Personal Mobility Ordinance

The Transportation Commission approved the following amendments to the Proposed Personal Mobility Ordinance:

- Clarified definition of personal mobility vehicle: self-propelled, not required to be registered
- Increased downtown signage
- Established disposal time frame of unclaimed vehicles
- Regulations for autonomous delivery robots

The Personal Mobility Ordinance was provided as a communication item to City Council July 20, 2021

The Personal Mobility Ordinance passed at City Council on September 20, 2021

Resolution in Support of Michigan Senate Bills 433 and 434 of 2021 Michigan House of Representatives Bills HB4835 and HB4836 of 2021

The Transportation Commission made revisions and recommendations to the resolution and forwarded the resolution to City Council as follows:

Whereas, Granting drivers licenses and state IDs to undocumented immigrants is an important part of making our streets safer for

Whereas, There are people in Ann Arbor who would legally be allowed to drive, but are currently restricted from obtaining a driver's license or state ID because of their immigration status;

Whereas, It is in everyone's interest that all drivers are trained, screened, and tested, to ensurethat they are familiar with Michigan driving regulations;

Whereas, Driver's licenses and state IDs remain default forms of identification, and lacking a drivers' license or state ID makes it much more difficult to raise a family, go to school, contribute to the state economy, and access housing and healthcare;

Whereas, When everyone who is legally allowed to drive can obtain a driver's license our streets will be safer for immigrant drivers and their families, and safer for all road users by ensuring that everyone driving is trained and licensed to do so;

Whereas, Senate Bills 433 and 434 of 2021 and House of Representatives Bills HB4835 and HB4836 of 2021 would restore the rights of everyone who would be eligible to obtain a driver's license or state ID in Michigan, including undocumented immigrants;

RESOLVED, Ann Arbor Transportation Commission supports Michigan Senate Bills 433 and 434 of 2021 and Michigan House of Representatives Bills HB4835 and HB4836 of 2021; and

RESOLVED, Ann Arbor Transportation Commission supports Michigan Senate Bills 433 and 434 of 2021 and Michigan House of Representatives Bills HB4835 and HB4836 of 2021; and

RESOLVED that the Ann Arbor Transportation Commission recommends that City Council pass a resolution in support of immediate passage of Senate Bills 433 and 434 of 2021 and Michigan House of Representatives Bills HB4835 and HB4836 of 2021 to ensure that all drivers are eligible to be trained, screened, and tested, to ensure that they are familiar with Michigan driving regulations.

The Transportation Commission Resolution to the Michigan Drive Safe Bills was provided as a communication item to CIty Council on June 21, 2021

ATTACHMENT A

Transportation Commission Ordinance

- 1:207. Transportation Commission.
- (1) The Transportation Commission is established to foster excellence in the planning, design, construction, and maintenance of a sustainable and resilient multimodal transportation network for the City of Ann Arbor. The Transportation Commission will serve as an advisory body to the City Council and the City Administrator on transportation policy with a focus on accessibility, mobility, equity, and safety for all citizens.
- (2) The Transportation Commission shall consist of 11 voting members. Appointments should be of individuals who, insofar as is possible, have an interest in the various forms and modes of transportation needs of the community. Members shall be appointed by the Mayor and approved by the City Council unless otherwise stated.
 - (a) To support a holistic evaluation of the community's concerns, the voting members of the Transportation Commission shall be as follows:
 - 1. Six members of the public.
 - 2. One owner or operator of a transportation business operating in Ann Arbor.
 - 3. One member of the Planning Commission, appointed by the Planning Commission.
 - 4. One member of the Commission on Disability Issues, appointed by the Commission on Disability Issues.
 - 5. One individual appointed by the board of the Ann Arbor Area Transportation Authority.
 - 6. One member of the City Council.

- (b) The City Administrator, the Transportation Manager, and the Chief of Police shall be nonvoting members of the Transportation Commission. The City Administrator shall designate staffing to support the Transportation Commission.
- (c) The Regional Transit Authority of Southeast Michigan, the University of Michigan, and the Ann Arbor Public Schools may each appoint one nonvoting member to the Transportation Commission.
- (d) Unless otherwise stated in this subsection, voting members of the Transportation Commission shall be appointed to three-year terms, which shall be staggered so that approximately one third of the terms expire each year. Initial terms may be for less than three years so that the terms are staggered. The City Council member shall be appointed for a one-year term in the same manner as for City Council committee appointments. Members appointed by other City boards or commissions shall continue to serve until they are no longer members of the appointing board or commission or until the appointing board or commission appoints a different member. The member appointed by the board of the Ann Arbor Area Transportation Authority shall continue to serve until the board appoints a different member.
- (3) The Transportation Commission shall have the following powers and duties:
 - (a) Advise the City Council and City Administrator on:
 - 1. Transportation grants.
 - 2. Streets and highways.
 - 3. The use of, restrictions on, and upkeep of public rights-of-way.
 - 4. Bus and rail service.
 - 5. Pedestrian and bikeway programs and projects

6.Safety-related programs and projects.
7.Regulation of vehicles for hire, including taxicabs, transportation network and ride-sharing entities, pedicabs, and other transportation vehicles; and all related matters including permits, annual permits, franchise permits, transportation franchise requests, renewals, rate adjustments, and hours of operation.

- (b) Provide comments to the Planning Commission, City Council, Downtown Development Authority, and the Ann Arbor Area Transportation Authority on transportation policy, and the impact of proposed projects to the same. (c) Recommend to the City Council and the City Administrator priorities and budget allocations related to transportation.
- (d) Provide recommendations on the City's transportation master plans including the City Transportation Plan and Non-Motorized Transportation Plan.
- (e) Report annually to the City Council and the City Administrator regarding the activities of the Transportation Commission, which shall reflect the effectiveness of the city's transportation strategy process and make recommendations for any changes thereto.
- (f) Make proposals and recommendations to achieve and maintain a holistic and inclusive transportation ecosystem that meets the mobility needs of all people, including the mobilityimpaired.
- (g) Form special purpose task forces and subcommittees to carry out the business of the commission.(h)Perform other duties as directed by City Council.
