#### OLD BUSINESS

**Ann Arbor Unarmed Response Plan**

*L. Jackson discussed the Interim Report on Unarmed Response in conjunction with the (Resolution R-21-129) approved last April. She talked about how other cities have initiated successful programs and hope Ann Arbor can create a similar program here. ICPOC commissioners would like to be consulted so they can contribute their recommendations during this process. She expressed how trained social and mental health workers will be a valuable asset to the city to help better serve people in crisis. F. Todor-Hargreaves suggest that in the beginning ICPOC should have some responsibility with the interaction between AAPD and County law enforcement when it comes to the involvement of armed officers.*

#### **Community Policing Innovation Fund Grant**

*L. Jackson gave an update on the Community Policing Innovations Fund in collaboration with the Southeast Michigan Criminal Justice Policy Research Project (SMART). The goal of the grant is to collect good data, analyze it, then disseminate the information to the community through town hall meetings, or a written report. This information will also be useful to the AAPD. The team will analyze the years; 2017, 2018 and 2019. L. Jackson asked any commissioners interested, please join us, there is data yet to be analyze. Commissioner S. Cater will participate.*

#### **NEW BUSINESS**

##### **Discussion of Community and Law Enforcement Public Safety Data Platform Funding**

*L. Jackson ask questions surrounding funding for the Law Enforcement Data Platform. Chief Cox discussed some of the funding will go towards training on the data platform. Commissioners would like access to the Data Dashboard and question what companies and software's are applicable to the City's software? F. Todor-Hargreaves suggest AAPD consider a system that load directly into a GIS. CM Song mentioned Open Data Collection, to increase transparency will help align shared goals.*

##### **Ann Arbor Traffic Stop Transparency**

*L. Jackson discussed a collaboration is up and running for Traffic Stop Transparency with the Transportation, and Human Rights Commissions and a draft resolution for City Council will be available shortly.*
