# Ann Arbor SPARK Metrics: JOBS

SPARK acts as project manager for both the communities it supports and the companies it serves. Our project management efforts can be fairly simple, such as conducting data analysis that a company may use in its business planning, or as complex as full project management for significant company expansions.

This would include everything from:

- Connecting them to proper resources
- Working with the site selection community to help determine a location for a project
- Fully managing the tax incentive paperwork and the process it may require
- · Creating communication plans
- Traveling to company locations outside of the state
- Making presentations to key public and private decision makers
- Talent recruitment efforts



When companies apply for local or state incentives, they fill out applications that require both job creation and investment estimates. SPARK considers these projects a success after it is publicly announced, or when the proper approval process has taken place for the incentive sought by the company. SPARK's jobs and investments numbers are based on these project announcements provided by the companies. SPARK monitors actual job creation and those results are shown in this report.

SPARK supports a company directly or it supports the consultants the company utilizes during its expansion. Whatever role SPARK might play, we capture jobs and investments for projects that we have played an active role in helping a company make a decision to move forward.

SPARK celebrates all projects that may have an impact on our region. We do not count jobs and investments where SPARK was not directly involved.

## **COMPANIES VISITED**

Growth calls are a core economic development strategy that involve proactively outreaching and engaging with the existing employer base in our region to determine where they face opportunities and challenges. Growth calls recognize that businesses are dynamic entities that involve constant change. These calls allow SPARK to:

- gather information about local businesses that can be aggregated to reveal trends,
- · determine valuable resources that could assist in the company's development,
- identify growth projects that require assistance, and
- serve as an ombudsman between businesses and government.

SPARK conducts hundreds of targeted growth calls each year that result in numerous referrals to resources, services and opportunities of which companies are often unaware. The most common referrals involve accessing talent, access to capital or business development/sales opportunities. Proactive outreach helps companies address challenges before they become problems, supports their continued growth and helps them see that this region is invested in their success.

# Sartorius BioAnalytical Instruments to construct a Center of Excellence facility in Ann Arbor

## **Pending City Approvals**

Sartorius BioAnalytical
Instruments, Inc., a global leader
in the biopharmaceutical industry,
received support today from the
Michigan Economic Development
Corp. to construct a Center of
Excellence facility in Ann Arbor.
The new facility will house lab
processing services,
manufacturing and assembly of
highly technical instruments,
reagents, research and



blewedopressortromes, rate times, training, a customer visitor center, and more. Throughout this process, Sartorious will invest \$57 million in the Ann Arbor region, which will ultimately create 160 high-wage jobs here.

Ann Arbor SPARK has worked with the company to identify a site for this new facility, secure support from state and local partners, and help with future efforts to hire top-tier talent. To support the project, the city of Ann Arbor plans to submit an application to the Michigan Department of Transportation for Transportation Economic Development Fund support for road resurfacing activities. The city also plans to consider a Brownfield TIF Work Plan and approval of a property tax abatement in support of the project.

On the collaboration between state and local partners, Ann Arbor SPARK president and CEO Paul Krutko said, "The staff at Ann Arbor SPARK has worked incredibly hard to bring this opportunity specifically to the City of Ann Arbor and we thank the MEDC, the Michigan Strategic Fund, and Governor Whitmer for approving the business development grant in support of Sartorious' new facility. This support from the State of Michigan is critical, but for the project to move forward, the City of Ann Arbor must approve companion local support that will allow the project to move forward in the Ann Arbor Research Park that has underperformed for decades.

The City and other taxing authorities will realize new tax revenues from this project from the very beginning if the project is approved by the city of Ann Arbor. Ann Arbor SPARK looks forward to City Council approving the local incentives in support of the Whitmer administration's actions to make this project a reality in Ann Arbor." Sartorious works with scientists and scientists and engineers around the world to quickly and safely develop and manufacture medications from the first idea to patients. The company's parent, Sartorius AG, is publicly traded and has 11,000 employees worldwide, including approximately 130 located at four sites in Washtenaw County.





# EDA GRANT ACTIVITY BROADBAND ACCESS

Ann Arbor SPARK, in partnership with the City of Ann Arbor, City of Ypsilanti, Washtenaw County, and American Center for Mobility has been awarded a grant from the Economic Development Administration (EDA) for funding to design and construct a new conduit and fiber network that will connect the city of Ann Arbor and City of Ypsilanti SmartZones. This project is an extension of the fiber project in the Ann Arbor SmartZone, which provides an additional dark fiber connection between the City of Ann Arbor and City of Ypsilanti and Ypsilanti Township, with the ultimate goal of ensuring residents have access to high-tech job opportunities in our community.

#### **How the Ongoing Pandemic Has Impacted Employment in the Ann Arbor Region**

As the coronavirus pandemic persists, businesses in our region continue to adapt and pivot to the best of their ability. The Ann Arbor region has experienced job loss since the beginning of the pandemic, but not at the same rate as other regions in Michigan. Between 2019 and 2021, nearly 400,000 jobs (395,573) were lost in Michigan with nearly 20,000 of those jobs (19,744 or five percent of all jobs lost in Michigan) being in the Ann Arbor region (Washtenaw and Livingston counties).

While many industries and occupations were negatively affected by the ongoing pandemic, some industries and occupations in and around Ann Arbor are thriving. High tech jobs like software developers, jobs related to life sciences, janitorial services, and medical-related services are a few examples of the industries and occupations that have added jobs since 2019.

Not surprisingly, the hardest-hit industries and occupations in the Ann Arbor region are tied to foodservice. Stay home orders, social distancing requirements, and other pandemic-related regulations have contributed to job loss in restaurants and other foodservice establishments throughout the region, and recent food supply shortages have not helped the situation. Recent legislation has passed in Michigan to create a \$409 million fund in the Michigan Treasury to <u>aid businesses</u>, including restaurants, that were negatively impacted by the pandemic and additional targeted relief is likely to come to fruition thanks in part to ongoing workforce and economic development advocacy work.

Compared to regions like the metro Detroit area with 188,554 total jobs lost (48 percent of all jobs lost in Michigan), the Ann Arbor region has fared relatively well in terms of employment, but that does not mean that some of our local businesses have not been severely impacted. Fortunately, resources to assist businesses during these challenging times are abundant in our area and the economic outlook for the region is positive. According to U-M's Economic Outlook for Washtenaw County (2021 – 2023), Washtenaw County will have recovered all the jobs lost during the recession and then some by the third quarter of 2023. Emsi Burning Glass also forecasts a recovery of jobs in the Ann Arbor region in the coming months.

## <u>Site Selection Resources and Insights: Key Takeaways from Swisher's 2021 Year-End Vacancy Report</u>

The team at Ann Arbor SPARK understands the concerns of businesses when it comes to relocation decisions, and the challenges site selectors face during the search. SPARK is dedicated to helping companies looking to grow, expand, or relocate find a space that suits their needs and has the resources and connections to facilitate your site selection.

In addition to the resources provided by SPARK's business development and entrepreneurial services teams, Melissa Sheldon, director of research for SPARK, analyzes commercial real estate trends in the region for two fundamental reasons. First, by understanding these trends we can provide the best possible advice to companies looking for space (those already local and those new to the area). Second, these trends are an important indicator of our region's economic health. Swisher's report focuses specifically on the Ann Arbor market, which is very different from other areas in southeast Michigan but can sometimes help predict market shifts in neighboring areas.

#### **KEY TAKEAWAYS**

Swisher Commercial recently released its <u>2021 Year-End Vacancy Report</u>. Swisher has produced an annual survey of vacancy rates for both office and flex space in the Ann Arbor area for 29 years now and it remains the most comprehensive public snapshot of commercial real estate vacancy in our area.

- 1. The ongoing pandemic continues to impact the demand for office and flex space throughout the Ann Arbor region as remote working continues to be a viable option for many companies, but vacancy rates are still far below those reported during the Great Recession.
  - Swisher surveyed 306 buildings of 5,000 square feet or larger, totaling nearly 11.7 million square feet. The total vacancy rate for office and flex space is 10.3 percent, up from 8 percent in 2020.
  - Many companies continue to offer remote working options and some companies that are in owner-occupied spaces have offered vacant space for lease as they have found they can operate with less office space.
  - As companies continue to evaluate remote working options and the need for
    office space, vacancy rates will continue to fluctuate, but there are many
    collaborative opportunities and co-working spaces that now exist as a result.

#### KEY TAKEAWAYS, Cont'd.

- 2. The only sub-market in Ann Arbor with a vacancy rate that decreased from 2020 to 2021 is north Ann Arbor, but the vacancies may just be delayed due to longer-term leases.
  - Vacancy rates increased from 2020 to 2021 throughout Ann Arbor areas except in the north office area. The north Ann Arbor area vacancy rate decreased from 7.0 percent in 2020 to 5.7 percent in 2021.
  - While the vacancy rate decreased in north Ann Arbor from 2020 to 2021, Swisher reports that they are aware of several large tenants in the north office area that plan to move out of their space in 2022 when their lease term ends.
- 3. There was more stability and demand related to flex space than office space in 2021 due to the in-person nature of work being done in flex spaces.
  - Flex/shop suites of a smaller size had the highest demand in 2021, contributing to the west flex-only area of Ann Arbor having the lowest vacancy rate in the market (2.8 percent, down from 4.5 percent in 2020).
  - Similarly, flex space in the south Ann Arbor area was mostly occupied throughout the year but increased from 3.1 percent in 2020 to 6.5 percent in 2021 due to one large flex building becoming vacant during Q4.
  - The dominant sector for building sales in 2021 was light industrial and flex space.
- 4. The downtown office area vacancy rate increased from 8.0 percent in 2020 to 14.2 percent in 2021 while the cost of office space has remained steady.
  - Swisher reports that landlords with space in downtown Ann Arbor have not widely decreased their asking rates on vacant office suites.
  - It is possible landlords will offer incentives in the future to try draw tenants back to the downtown office area but plans for landlords to offer incentives or lower lease rates are unknown at this time. Further complicating this issue is the fact that it is not known what the long-term effects of the pandemic will be in any of the sub-markets of commercial real estate in and around Ann Arbor.

In summary, the overall commercial real estate market in the Ann Arbor region remains strong and adaptable, but the downtown office area is experiencing challenges as the pandemic persists. Due to the increased cost of real estate and construction in general, many businesses are bringing new life to previously vacant existing spaces throughout the region, standing up co-working spaces in their owner-occupied buildings, or implementing other creative and collaborative solutions related to their needs for physical space. As 2022 unfolds, we will continue to monitor these trends to help businesses thrive in our region.
