# Dear City Officials,

The ARPA funding is intended to help recover from the impacts of the pandemic. As a volunteer with a local social service agency and as a resident, I am aware of the devastation that so many people continue to experience these past two years. Lack of food and shelter, the very basics for sustainability, are at the forefront. Trauma and depression are close behind. We see many clients every day who are suffering.

This is an urgent request to address these needs with ARPA funding. I realize that an election center, solar power, and bike facility, for example, may be on the City's wish list, but I think that the vast majority would agree that urgent human needs, the funding of which has been cut by the disbanding of COFU, should be a top priority. Hungry and traumatized clients need a safety net that is not being supported adequately by the federal, county, or local governments.

From the ARPA funding, please allocate

- **At least** \$4M for coordinated funding support
- At least \$3.5M for property acquisition for affordable housing
- At least \$1M for housing for homeless households

Allocating 35% of the \$24M which is intended for pandemic relief to be spent on safety net services is prioritizing a humane and moral approach to human suffering.

I am a Ward 1 resident and in watching tonight's council meeting was absolutely shocked to hear your resolution for allowing the bridge widening, with five lanes of traffic and minimal increase in Non-motorized transport space.

Were you at the Transportation Committee meeting where this issue was discussed? The UM Representative made it quite clear at that meeting that single-occupancy automotive traffic was the main reason for expanding this bridge at that meeting, saying that most patients were not currently walking or biking to appointments and therefore those users do not really deserve much roadway. Are there plans to do road diets on Fuller or Plymouth? These roads are representative of what this bridge will become, lane wise - have you ever tried to navigate those by bike or foot and if so is there some reason I'm missing to make more roads like that? Is there some research I'm missing about how adding more lanes actually does improve non-motorized transport options and reduces automobile usage?

I have been, on the whole, pleased with your voting record and past representation, especially when it comes to your leadership on the zoning and development changes. I am shocked by this last proposal and trying to understand what your logic was in making this assessment.

Hello Council-members,

Though I now live in Scio Township, I want to express my support and gratitude to those of you working to keep the hospital bridge wide enough for safe use by pedestrians and cyclists.

I used to commute by bike from Ann Arbor to Ypsilanti, crossing this area twice, and I always found this section to be the most precarious juncture, with many walkers and bikers crossing in the same places (because it's unsafe to bike on the road there). We've also all heard our medical worker friends bemoan the parking situation at the hospital where it seems there are no additional options for parking. An investment of a redesign for this bridge that creates more space for cars and less for cyclists, pedestrians, and those using wheelchairs would be a real lost opportunity for our community. It would also needlessly tarnish Ann Arbor and the university's stated goals on carbon reduction.

I grew up in Ann Arbor admiring my parents' non-car commuting lifestyle (my dad biked and my mom walked). I saw the ways their non-car commutes introduced them to more neighbors, benefitted their physical and mental health, and took a couple cars out of traffic snarls. Now as a working adult, I am thrilled to be benefitting from the B2B project as a mode to safely, enjoyably and easily get to work by bike. Riding the B2B makes me love living here and so hopeful about our future as a community. I would not bike to work if it didn't exist. I think many people my age (32) would like to trade in their car commutes for something better, but we need the city to lay the path. Please don't give up on advocating for people traveling by foot and wheel.

Dear Fellow Elected Officials,

Earlier this fall, we all signed on to a letter expressing our concern, commitment and continued support to survivors and customers of SafeHouse. We encouraged the Board of Directors of SafeHouse to place the Executive Director on paid leave while conducting an independent investigation. We further stated that "We want to ensure that women in Washtenaw County have the protection and resources they need, and we will continue to advocate vigorously for this cause."

Several months have passed. SafeHouse is providing some seemingly reduced sheltering and wrap-around services. Washtenaw County has sheltered survivors and connected them with wrap-around services. The SafeHouse Board of Directors has not shared the results of the independent investigation and has left the Executive Director on unpaid leave.

I believe we all had a vision of what domestic violence survivor services entailed before the malfunction of SafeHouse showed us the state of domestic violence services as they are in Washtenaw County. Even as a commissioner attempting to coordinate services for several survivors, I found dead-ends, well-meaning but unproductive passing around organizations, and unreturned phone calls in addition to some wonderful successes with finding help. I am not satisfied that we as a community are providing the protection and resources that women and families experiencing or who have experienced domestic violence need. I would like to see something much more robust, coordinated and expansive than the emergency services SafeHouse states they provide.

Would you please join me in a conversation to understand what services are available in Washtenaw County, and to envision what services might be desirable and attainable. This will be the first of what I hope will be numerous conversations that will ultimately include a broad representation of community stakeholders.

I am providing some times that could work. I know that we are all busy and it might be hard to find a time that works for everyone. Let's give this a try. Would any of these times work for you? I will schedule the one that works for most of us.

My name is Elke Kramer, I have been living in Ann Arbor since 2002. I am a business owner, member of the Michigan Human Trafficking Task Force, and volunteer for the Michigan Abolitionist Project and after having seen the horrible outcomes of decriminalization of prostitution in Europe, where I am from, I write you today to urge you to KEEP City Ordinance Section 9:62 (h) in place, PLEASE do not remove this ordinance.

- 1. This ordinance is an important tool that not only helps police investigate human trafficking, but also enables them to refer victims to life-saving community services. Without this ordinance, funding and service referrals may not be possible.
- 2. Without this ordinance, law enforcement may not stop anyone, minors or adults. Those who are exploited will not be identified, which means they are not compliant with state laws.
- 3. I urge you to leave this ordinance in place until the Michigan legislature has completed revision of laws related to human trafficking. Our Human Trafficking Commission is working diligently with the legislators on updating the state laws regarding human trafficking and prostitution. It is most advantageous to wait until these laws are in place and then mirror the city ordinance to the state

laws.

4. In addition, and most importantly, when addressing human trafficking via any policy, ordinance, training or practice, it behooves us to include the voices and skills of those with lived experience – human trafficking survivors. I know many survivors who gladly will assist community representatives in understanding the complexities of human trafficking and how best to address these.
