
WATER MAIN EASEMENT SKETCH

PARCEL DESCRIPTION (09-09-32-300-001):

(PER WASHTENAW COUNTY TAX ROLLS)

A parcel of land being part of the SW 1/4 of Section 32, Town 2 South, Range 6 East, City of Ann Arbor, Washtenaw County, Michigan, described as follows:

The SW 1/4 of said Section 32, EXCEPT that part beginning at the intersection of West line of Main Street (96 feet wide) with the South line of Stadium Boulevard (80 feet wide); thence South 10 feet along the West line of Main St.; thence to a point at the South line of Stadium Blvd. 10 feet from the intersection of West line of Main St. with the South line of Stadium Blvd.; thence East 10 feet to the Point of Beginning. Subject to all easements and restrictions of record, if any.

WATER MAIN EASEMENT

A 40 foot wide easement for water main being part of the SW 1/4 of Section 32, Town 2 South, Range 6 East, City of Ann Arbor, Washtenaw County, Michigan. The easement is 20 feet on each side of the following described centerline:

Commencing at the monumented Center of said Section 32, being a found capped iron with a cap # 41092; thence S 87°30'00" W 613.50 feet along the E-W 1/4 line of said Section 32; thence S 03°08'31" E 127.66 feet to the Point of Beginning; thence along the centerline of said easement the following four (4) courses; 1) S 03°08'31" E 161.26 feet, 2) S 44°33'05" E 51.36 feet to a point on an existing 12" water main, 3) S 43°01'02" W 314.45 feet, 4) S 65°31'02" W 67.96 feet along said existing 12" water main to the Point of Ending. Contains 23,801 square feet or 0.546 acres of land. Subject to all easements and restrictions of record, if any.
