- a) Public hearing regarding Washtenaw Urban County Annual Action Plan: (Tara Cohen)
 - Tara shared information about the CDBG fund, ESG fund, and the HUD plan

 - Tara shared that every 3 years municipalities that are outside of the urban county are presented the opportunity to join
 - Anna Erickson asked, are there additional work that municipalities need to do if they join the urban county?
 - Tara shared that there is additional work if the municipalities take on projects but the work is not prohibitive for participants and provides a lot of utility for low-income residents
 - A. Foster asked, is it common that only Avalon applies to the RFP?
 - O Tara shared that Habitat for Humanity has applied in the past and the current landscape of applicants is generally similar
 - Emily asked, what kind of public comment is taken for the action plan?
 - Tara shared that information is gathered from the public at various points throughout the process

- Brett Lenart (City of Ann Arbor) started the series by discussing zoning
 - Brett started with the exclusionary and racially focused national history of zoning laws
 - o The presentation continued, focusing on the history of zoning in Ann Arbor
- Missy Stults (City of Ann Arbor) continued by talking about population density and sustainability
 - Missy shared information on the pollutant emissions from existing housing infrastructure and the initiatives that are promoting sustainability
 - Missy also shared the connection between population density and pollutant emissions/sustainability
- Jennifer Hall (Housing Commission) presented on real examples of how the topics discussed by Brett and Missy come together in an affordable housing project
 - Jennifer described different affordable housing projects that have been completed throughout the County and information about applying for funding for these projects

c) Request for support from a group working on an unarmed response plan that is being presented to City Council

 HHSAB does not have quorum so it cannot pass a formal resolution. However, members can send individual emails in their capacity as an HHSAB board member

d) New Human Services Partnership Update

- Nathan shared that the OCED is looking for community reviewers for the safety net grant funding round
 - A. Foster asked if someone is not available to participate during the May review dates, should people still apply?
 - Nathan said that he was not fully sure, but people should apply, and he will check with Teresa
 - A. Foster asked if there is an age limit for community reviewers and if minors are allowed to be reviewers
 - Nathan will take this question back to Teresa
- Councilmember Song also shared that there will likely be an \$100 stipend for participants

VII. <u>City Council Member Update</u>

- Councilmember Radina updated the group about suggestions that HHSAB made regarding ARPA funding
 - A resolution for allocating \$500,000 for housing support services with the intention of supporting low-income residents passed
 - Additionally, of the \$500,000 allocation for the arts, \$200,000 has been specifically committed for arts programming focused on mental health support and addressing trauma
- A new city attorney has started this week
- Councilmember Song shared that Ann Arbor is the first city in Michigan to run a UBI pilot project that allocates a total of 1.6 million dollars to 100 low-income families over 2 years
 - Detroit is thinking about doing a similar program
- Councilmember Radina shared that TC1 passed which impacts zoning

 A. Foster noted that closed captioning should be turned on for future meetings

IX. Public Comment

A. Foster shared that the Ann Arbor library has added a NARCAN dispenser which can be used to treat opioid overdoses
