**City of Ann Arbor Expanding Public EV Charging Downtown.** The City of Ann Arbor Office of Sustainability and Innovations (OSI), in collaboration with the Downtown Development Authority (DDA), is working to expand public electric vehicle (EV) charging in downtown parking facilities. The city's sustainability goals include providing access to public EV charging, which is one of the primary ways a city can support the transition to electric vehicles.

As part of this work, the city and DDA are supporting the installation of 80 electric vehicle charging ports in seven parking structures, more-than doubling the number of public charging points in the public parking system. Parking structures receiving new or additional chargers include:

- Ann/Ashley.
- · Fourth and William.
- Library Lane.
- Maynard.
- Liberty Square.
- Forest.

Ann Arbor Identifies Key Infrastructure Projects Responsive to Federal Funding. The City of Ann Arbor has identified key infrastructure projects that are aligned with the federal funding that will invest trillions of dollars across the country over the next five years. Funds are being distributed through federal and state agencies, but also directly to municipalities in some instances. In order to maximize and coordinate with potential funding opportunities, the City of Ann Arbor's infrastructure agenda outlines eligible projects needing federal and state support.

Ann Arbor Seeks Input for Parks and Recreation Open Space Plan. The City of Ann Arbor Parks and Recreation Open Space Plan process is now underway. An online survey is gathering community feedback to help identify goals, needs and priorities for Ann Arbor Parks & Recreation for the next five years. The survey will close June 5, 2022.

Ann Arbor Shares List of Road, Sidewalk, Utility & Resurfacing Projects Planned for 2022. City of Ann Arbor released its list of road and sidewalk projects scheduled for construction in 2022. This year's resurfacing/reconstruction projects will involve 3.6 miles of major roads and 7.5 miles

of local streets. This year's capital preventive maintenance program will involve 16.5 miles of major roads and 8.6 miles of local streets. City of Ann Arbor Natural Area Preservation (NAP) works to protect and restore Ann Arbor's natural areas and to foster an environmental ethic among its community. This involves conducting plant and animal inventories, ecological monitoring and stewardship projects in Ann Arbor parks. These tasks are performed by both staff and volunteers. NAP is sharing events planned for June 2022.

# LAND ACKNOWLEDGEMENT

Equity and justice are at the center of A<sup>2</sup>ZERO and staff in OSI are continuing to ground our work in these critical principles. In that light, we'd like to take a moment to honor the geographic and historic space we share. We acknowledge that the land the City of Ann Arbor occupies is the ancestral, traditional, and contemporary lands of the Anishinaabe and Wyandot peoples. We further acknowledge that our city stands, like almost all property in the United States, on lands obtained, generally in unconscionable ways, from indigenous peoples. The taking of this land was formalized by the Treaty of Detroit in 1807. This month, OSI is spotlighting A<sup>2</sup>ZERO Ambassador Jennifer Peterson-Price. Jennifer grew up in Ann Arbor and attended elementary, middle, high school and college here. After college, she moved around a bit before returning to Ann Arbor six years ago.

After finishing the A<sup>2</sup>ZERO Ambassadors training course, Jennifer chose to work with a team of Ambassadors on a project focused on engaging Ann Arbor's school age students with the A<sup>2</sup>ZERO Plan. The Ambassador group worked with students to identify ways they could help the city achieve its carbon neutrality goals. Now the team is working on creating a pilot project targeting school lunch waste reduction by teaching kids about composting and by launching a contest among lunch periods to see who can reduce their waste the most. This contest begins in May at Eberwhite Elementary and will hopefully soon expand to many other schools in Ann Arbor!

#### 10,000 Trees Initiative

#### Aging in Place Efficiently

Our AIP pilot project – offering energy efficiency improvements and home safety installs to support older, income-qualified adults wishing to age-in-place – has been completed in six homes, with 11 additional homes in progress! We are looking to scale the model up in conjunction with Washtenaw County to ensure that the investments in AIP homes help to stabilize housing stock and support inter-generational home retention. Meanwhile, we are collecting feedback from participants, vendors, and partner agencies; compiling participant data for evaluation; and actively seeking additional financial support. The City has installed two solar-powered AQMesh air quality monitors - one at the Kerrytown Farmer's Market, and another at the Bryant Community Center; and are working to install additional air quality monitors at a local Elementary School and on Main Street at the intersection with Washington, with further locations in the works. These monitors will measure pollutants such as particulate matter (PM), carbon dioxide, carbon monoxide, ozone, and nitrous oxides. All data collected by the monitoring network will be made publicly available. #### Ann Arbor Reduce, Reuse, Return (A<sup>2</sup>R<sup>3</sup>)

US-made; USDA-approved; microwave-, freezer-, and dishwasher-safe reusable containers are available for select takeout orders at Zingerman's Next Door Café, Ginger Deli, and El Harissa Market Café. Containers can be returned to participating businesses to be cleaned and used for future takeout orders, reducing single-use container waste, and supporting Ann Arbor's circular economy. Additional businesses will be added to the program continually. #### **Circular Economy**

The circular economy is an economic system that generates value by reusing, repairing, sharing, lending, and promoting all activities that give goods and resources a new life or extend the useful life of an item. Strengthening our circular economy is outlined in Strategy 5 of A<sup>2</sup>ZERO and it's an exciting area of existing and future work in the City. The City just released <u>this website</u> to provide more details about emerging workstreams related to the circular economy – check out some great resources and get ready to give feedback on what you think a circular economy means for Ann Arbor (public input request coming soon).

#### **City Fleet Electrification**

We've procured two electric refuse trucks for the City Fleet, partially funded with over \$600,000 in Federal and State grants. So far, we have exceeded 15% electrification of the City's light fleet! #### **Commercial and Multifamily Energy and Water Benchmarking**

Last year, City Council passed an energy and water benchmarking ordinance. To support implementation, OSI has procured benchmarking software to provide data collection and organization, as well as customized help desk functionality. We are also coordinating with the 2030 District, five UM SEAS students, and five volunteers (including A<sup>2</sup>ZERO Ambassadors) to provide support for the program. #### **Electrification of Vehicles and Electric Vehicle Readiness**

The City's Planning Department, with help from the Transportation Electrification subcommittee of the Energy Commission, is considering improvements to the EV Readiness Ordinance, which will be submitted to the Ordinance Review Committee. Additionally, four DC fast chargers were installed at City Hall this winter, and the DDA has signed a ChargePoint agreement to deploy 80 charging ports across DDA parking garages. We are also assisting multi-unit dwellings interested in EV charging by connecting them with incentives, contractors, and other resources. #### **Energy Concierge**

With help from the Energy Concierge Service subcommittee of the Energy Commission, OSI has evaluated the pros and cons of multiple energy concierge service business models, interviewed vendors that provide energy concierge platform development and energy advisory services, and developed a draft work plan. OSI is currently working with the City's IT office to develop an energy concierge service website, based on lessons learned. The energy concierge service will provide consolidated and organized educational information on energy efficiency improvement, electrification, and renewable energy options. We are also working with A<sup>2</sup>ZERO Ambassadors to provide workshops where homeowners can share experiences on home energy upgrades. #### **Green Rental Housing**

OSI created a green rental housing task force composed on property owners, renters, landlords, and affordable housing colleagues which worked for months to develop green rental housing policy recommendations. These recommendations were shared with he public from February through April 2022. Feedback is currently being assessed, and updated policy recommendations will be released soon. #### **Home Electrification and Heat Pumps**

The Electrification Contractor Badging program, created in partnership with Michigan Saves, assists residents in finding qualified professionals (e.g., HVAC technicians, plumbers, energy auditors, electricians, and solar contractors) who can assist them with home electrification efforts. Contractors are completing the training now, and badged contractors can be found on the Michigan Saves locator tool (<a href="https://michigansaves.org/find-a-contractor/">https://michigansaves.org/find-a-contractor/</a>) by searching "Electrification." Additionally, OSI staff are participating in an RMI cohort of cities and front-line organizations across the country working on electrification campaigns, with targeted goals around program design and implementation. The Electrification webpage has been updated with additional information and resources at <a href="https://www.a2gov.org/electrify">www.a2gov.org/electrify</a>. Additionally, the IBEW/NECA, our local Electrical Workers Union, is partnering with A²ZERO on electrification readiness and is launching a campaign called "<a href="https://www.apartnering.com/The Future">https://www.apartnering.com/The Future</a> is Electric." As part of this campaign, they are releasing <a href="https://www.apartnering.com/Informational videos">https://www.apartnering.com/Informational videos</a> to help residents know what might be involved with upgrading homes for electrification of appliances and vehicles. Finally, OSI is also planning an <a href="mailto:Electrification Expo">Electrification Expo</a> for July 15th at the Ann Arbor Farmer's Market. #### **Home Energy Rating Disclosure (HERD)**

City staff have developed a pathway to Home Energy Rating Disclosure implementation based on best practices from RMI. #### **Municipal Energy Use**

The City is working with two firms to design over 4MW of solar energy systems for various municipal sites - including City Hall, the Water and Wastewater Treatment Plants, the airport, and various Parks sites. Funding for this project is coming, in part, from the American Rescue Plan Act (ARPA). Additionally, the City is conducting energy audits of various municipal sites, to understand energy consumption and make improvements where needed. In addition, the City is working on the final details related to the proposed 20MW landfill solar project. For more information on municipal energy use, please contact Simi Barr at SBarr@a2gov.org.

#### Neighborhood-Scale Climate Action – Bryant

The City continues to collaborate with the Community Action Network, the residents of the Bryant neighborhood, Elevate, and other collaborators to make Bryant the first fully decarbonized existing neighborhood in America. OSI is delighted to share that the project team recently won a Solar Moonshot grant to support two households with deploying solar, as well as a continuation grant from the McKnight Foundation to continue and deepen our engagement work in Bryant. The City and partners also applied for a U.S. Department of Energy grant to help provide deep weatherization support for up to 30 households in the neighborhood. We should know more about that grant by fall. In addition, energy audits of neighborhood residences are now underway. #### **Net Zero Energy Affordable Housing**

Working in collaboration with the Ann Arbor Housing Commission, OSI continues to advance energy waste reduction, electrification, and solar energy deployments at affordable housing sites. This includes a \$3 million earmark received from Congresswoman Dingell to support the transition of 3-4 existing affordable housing sites to as close to net zero energy as possible. The team is currently working on the RFPs for solar installations and electrification support at these sites so more details available soon. #### **Proposed Municipal Sustainable Energy Utility**

In January, Ann Arbor City Council voted to move forward design work related to the proposed Ann Arbor municipal Sustainable Energy Utility (SEU). This includes starting to register public interest in the utility, designing potential governance and staffing structures, conducting a rate analysis, and studying the technical and economic elements of deploying micro- and nano-grids as part of the SEU. #### **Solarize**

New Solarize groups are forming for May and June – join a group to receive discounts on solar, or simply to learn more – no commitment required. The 2-year-old Solarize program has hit the milestone of 3 MW of new solar in our region! This represents well over 450 installations, over \$1.5 million saved in upfront costs, and well over \$15 million saved in energy costs over the 25-year warrantied lifespan of solar panels. The program is also introducing a whole segment of the population to the topics of electrification and energy efficiency and is deepening our residents' connection to their energy usage and production. The Great Lakes Renewable Energy Association (GLREA) is now assisting folk outside of Washtenaw County in implementation of Solarize groups utilizing the Ann Arbor Solarize Toolkit. #### **2022 Construction Projects**

# **Annual Street Resurfacing Project**

This suite of projects encompasses the majority of the City's street resurfacing activities and includes some asphalt path resurfacing. Local resurfacing work in 2022 will occur primarily in the area bounded by Miller, Maple, Jackson, and Huron. Resurfacing of various segments of asphalt paths is also included. The complete list of streets included in the 2022 program is posted on the <u>project website</u>. Work is scheduled to begin in mid-May.

# **Sidewalk Gaps**

Gaps in the sidewalk system that are expected to be filled in 2022 include (some tentative timelines shown in parentheses):

- Barton Drive (north side from Brede to Pontiac) Substantially completed in 2021, however the new crosswalk will remain closed until all project elements are completeLighting and pavement markings are in. Crosswalk will be opened once crosswalk signage is installed.
- Boardwalk Drive (east side from Eisenhower to Oakbrook) construction in mid-May
- Broadway (north/west side from Broadview Ln to Plymouth)
- Ellsworth Road (north side, State to Stone School)
- Hiscock Street (east side, near Summit)
- Hutchins & Prescott (near Stadium)
- South Main Street (address 2878)
- Newport (east side from Sunset to Downup Circle)
- Nixon/Traver (Westbury to Logan Elementary)
- Platt Road (address 2231)
- Russell Street (with first time paving project) construction in late summer
- Saunders Crescent (address 1121)
- Scio Church Road (north side from Landmark Court to Winsted and Greenview to Seventh)
- Tuebingen Parkway (Lancashire to Traver)
- Winchell, Brockman, Frieze loop
- Yost and Eli (at frontage of 2609 Yost Avenue) construction began May 11<sup>th</sup>, and should be completed by the end of May

#### **Division Street**

City staff have completed engagement and analysis of extending the cycle track from Division to Hoover and recommend moving forward with this configuration. Staff will bring forward an item to the Transportation Commission in May which will then be forwarded to City Council to eliminate on-street parking to make way for the cycle track.

## Platt Road (Huron Parkway to Packard)

This is a Federal aid project which consists of resurfacing, watermain replacement work and pedestrian improvements. Final plans have been submitted to MDOT for review. Construction is scheduled for late summer 2022.

#### **Earhart Road**

This is a Federal aid project which consists of the resurfacing of Earhart Road between Geddes and Greenhills Drive. The project scope includes resurfacing and the addition of bike lanes. Construction is anticipated in the summer/fall of 2022.

#### **Broadway Street (Plymouth to Plymouth)**

This project includes the replacement of an aging watermain as well as resurfacing of the street. The project will also replace the existing speed humps and fill sidewalk gaps on the north side of the road at the east end of the project. Design work on the project is underway and construction is scheduled for late summer/fall of 2022, however it is possible that this project may slip to the spring of 2023 due to material shortages. A public engagement meeting is being planned for this project and details will be shared with Transportation Commission when available.

# Huron Parkway/Tuebingen Resurfacing (Nixon to Traver)

This project includes road resurfacing, filling of a sidewalk gap, repair of culvert headwall, and evaluation of the existing pedestrian tunnel. Construction is expected to begin in July 2022.

#### **Geddes Ave Resurfacing (Observatory to Highland)**

This project includes resurfacing, stormwater improvements, and crosswalk upgrades. Construction is expected to begin in July 2022.

#### South Main Street Reconfiguration Pilot (Packard to Stadium)

South Main Street from Packard to Stadium was reconfigured from a four-lane cross section (2 vehicle lanes in each direction) to a three-lane cross section (1 vehicle lane in each direction, a center turn lane, and protected bike lanes) as part of the 2021 Healthy Streets Program. Staff has completed engagement and analysis of this reconfiguration and will make it permanent this summer. A memo will be shared with the Transportation Commission in May and with City Council shortly thereafter.

# **Projects Currently in Design/Planning**

#### **Barton Drive Bike Lanes**

When Barton Drive was resurfaced in 2020, staff had proposed the removal of on-street parking between Pontiac and Northside in order to install dedicated bike lanes. This proposal was supported by the Transportation Commission and then presented to City Council for their approval (Chapter 10 of City Code requires approval from City Council to eliminate on-street parking for more than one block). At that time, Council tabled the Resolution, saying that the results of the Lower Town Study should be finalized before making this determination. The Lower Town Study is now complete and recommends bike lanes on Barton Drive. To that end, staff is seeking to bring this Resolution back to City Council for their consideration. Further details will be shared once available.

#### **State & Hill Improvements**

This is a Federal aid project (Surface Transportation Program, Highway Safety Improvements Program, and COVID relief funding). The project limits are as follows:

- State Street (South University to Packard)
- State Street (Hoover to Granger)
- Hill Street (Fifth Ave. to Church)

The project scope includes watermain replacement and lead transfers, street resurfacing, non-motorized improvements, crosswalk upgrades, new streetlights, and the evaluation and potential installation of the segment of the Treeline Trail along State Street south of Granger. A public engagement meeting was held on April 26<sup>th</sup> to gather initial feedback on the project. Additional public engagement opportunities will be forthcoming and will be communicated to the Transportation Commission in advance. A presentation will also be scheduled for a future Transportation Commission meeting.


#### Other Updates and Information

#### **MDOT Coordination**

The City has regular coordination with MDOT on State projects within the City. MDOT allows for locally installed improvements on their facilities, subject to their review and approval. The following projects are currently being coordinated with MDOT:

- Huron/Revena signal modernization MDOT has agreed to the City's request to add a signal at the intersection of Revena and Huron. This work will include a new crosswalk on the eastern leg of the intersection across Huron.
- Huron/Seventh signal modernization MDOT is proceeding with design of signal
  modifications at Huron and Seventh. A left turn restriction will be implemented for
  the southbound to eastbound movement. Conversely, a protected green arrow
  phase will be added for the northbound to westbound movement. Some
  realignment will occur on the north leg of the intersection to shift the vehicular
  travel lanes, bring the bike lane up to the signal, and make pedestrian signal
  improvements.

#### **Streetlight Implementation**

New streetlights were installed on Newport at Lowell/White Oak. 472 streetlight outages have been addressed to date by DTE in 2022. Additionally, work continues on streetlight maintenance which paints, replaces, or performs other preventive maintenance work on existing City-owned streetlights to ensure operability.
