WATER RATES

ORDINANCE TO AMEND SECTION 2:63 OF TITLE II OF THE CODE OF THE CITY OF ANN ARBOR

The City of Ann Arbor ordains:

Section 1. That Section 2:63 of Chapter 29 of Title II of the Code of the City of Ann Arbor be amended to read as follows:

2:63. - Water rates.

- (1) The commodity charges for water service are as follows. The rates shown are per unit, one unit equals 100 cubic feet (1 CCF).
