This sounds like I would have to continue to wait for any changes and would not be allowed to pull a permit? I did already pay for it and there is plenty of other work to be done other than the pole height. The panels themselves are mounted no higher than 21'.

My recollection of this matter is that solar was proposed to be mounted on a pole higher than 21 feet. The changes for this would be an amendment to the City's Unified Development Code that did one of two items:

- Increase the permissible height of any accessory structure in the City (currently limited to 21 feet).
- * Provide a specific height exception to solar panels in the City. While the UDC does provide this flexibility for rooftop solar, we do not provide the same for ground mounted solar panels.

The Planning Commission's work program identifies solar readiness as a potential ordinance amendment in 2022, however the Ordinance Revisions Committee has only just begun the conversation (last evening), so any changes, however recommended, I would anticipate for late this year.



Hello neighbors!

Welcome to everyone who is new to this newsletter! Before every Council meeting, I write up my own summary of each agenda item and try to pull details that I think are most relevant to understanding them. My hope is that these summaries can help residents keep track of what City Council is doing. For issues that matter to you, I encourage you to follow links (next to each agenda item) to the City's Legistar website, where you can find all the background information.

We have an exceptionally long Consent Agenda this week, but our regular agenda is extremely

short. A few Consent Agenda items are worth noticing:

Michigan Homeowner Assistance Fund

Item CA-23 will allow the City to be a service partner for the Michigan Homeowner Assistance Fund, which distributes federal support (ARPA funds) for homeowners who have experienced financial hardship directly related to COVID. In order to qualify, residents must apply for funds related to their primary residence and have a household income of less than 150% of AMI (Area Median Income). When the City becomes a service partner for this program, qualifying Ann Arbor residents will be eligible to receive funding for delinquent utility bills and property taxes.

Annual Sidewalk Repairs

As described on this City's website, public sidewalks are repaired or replaced on a 5 year rotation, funded by the Street, Bridge, and Sidewalk Millage approved in 2016: https://www.a2gov.org/departments/engineering/pages/sidewalk-and-ramp-repair-program.aspx

From that link, this year in Ward 4 sidewalk repair is planned for the Lawton neighborhood (area 2022-02). According to the City, it will begin in early July, estimated to be completed by middle of August.



Item CA-18 will fund the "2022 Sidewalk Repair Project," for repair and leveling of sidewalk slabs that have settled and hold water, have caused a displacement to adjacent slabs, or do not slope in the correct direction. The contract amount was increased from \$93,600 to \$191,600 after City staff determined that more slabs needed repair.

Item CA-19 will approve a change order to add funding for the "2021 Annual Sidewalk and Ramp Repair Project," continuing a plan for work that started in 2021. From the staff memo for this item: *The number of repairs needed in the planned 2021 areas was greater than the estimated quantity, requiring this first and final change order (\$139,399.27), which exceeds the*

contingency originally approved by Council (\$60,000). This Change Order will bring the total contract amount to \$720,962.42 and will allow for final payment to the contractor and subsequent closing out of the contract.

She spent her childhood in Ann Arbor, attending Eberwhite Elementary, Tappan Middle School, and Pioneer High School. She still lives on the same street with the Ward 4 neighbors who love her and watched her grow up. Jasmine is an amazing boxer who has accomplished a lot in the sport — she now qualifies for the 2024 Olympics!

I first heard about Jasmine a few months ago, when her neighbors were promoting a GoFundMe to help pay expenses for Jasmine to travel to a boxing tournament. I reached out to her then, to learn more about how our community could help. I met Jasmine for the first time in person last week, at a meet and greet. I do not know a thing about sports and so Jasmine's athletic accomplishments are difficult for me to explain and describe. I was amazed, learning about how many hours Jasmine trains and how many competitions she has participated in and won over

the years!

I learned last week: Jasmine's accomplishments are much more than she will volunteer on her own, but her friends and neighbors jump in to remind her (and share with others!) just how remarkable she is and the many things she has achieved in her career. Ward 4 neighbors who know Jasmine are eager for everyone to learn about the local celebrity in our midst! Jasmine is currently ranked #1 in the U.S. (54 kg class) and is a 10X national boxing champion. You can see her ranking here:

Jasmine has qualified for the Olympics in two different weight classes, but I didn't know quite what this meant until I had the chance to ask her about it. Jasmine placed first in her own weight class and then lost enough weight to compete and qualify in a lower weight class as well! Many boxers are afraid of Jasmine because she is so tough to beat.

The rest of this year, Jasmine is looking ahead to national tournaments in Detroit, Oklahoma, and Texas. This month, she's also participating in a special tournament in Belfast, Northern Ireland. Ordinances - First Reading

In order to amend the city code, Council must vote to approve the change, via ordinance, at two Council meetings. The following proposed ordinances are being introduced for "first reading". If approved, the ordinance will be voted on at a subsequent Council meeting ("second reading"), where it will also be subject to a public hearing.

C-1 (<u>22-0760</u>) An Ordinance to Amend Chapter 55 (Unified Development Code), Zoning of 1.49 Acres from TWP (Township District) to R1A (Single-Family Dwelling District), <u>3090</u>
<u>Geddes Road</u> (CPC Recommendation: Approval - 8 Yeas and 0 Nays)

A Township island at <u>3090 Geddes Road</u> has been annexed into the City to allow access to City utilities. This parcel will be zoned R1A (Single-family), which is consistent with the adjacent zoning, the surrounding land uses, and the City's Comprehensive Plan.

Additional thoughts...

I am spending more and more time out and about talking to people— I cannot reach everyone, so I am especially grateful when residents tell me "My neighbor told me about you!" Or "A friend told me about you!" If you support me and would be willing to host a yard sign, just let me know!

In this campaign season, I am often asked to explain my point of view and record as a Council Member in just a few minutes. This morning, I gave a short comment at the monthly meeting of the Washtenaw County Dems. Below are the three minutes that I planned to say (before learning that I only had TWO minutes!).

My name is Elizabeth Nelson and I have served on Ann Arbor City Council, representing Ward 4 since 2018. I grew up outside of Chicago, but I have lived in Ward 4 since 2004. Twenty some years ago, I trained as a lawyer but more recently, I became a certified teacher. I currently teach at a local preschool. My biggest non-political accomplishment is that I have taught preschool inperson since September 2020— this was more challenging and rewarding that I could have ever imagined!

I am deeply committed to the idea that our local democracy is stronger when we deal in facts. At higher levels of government, our democracy is in danger when a lack of information and aggressive misinformation dominate our political discussions. As democrats, I believe that we WIN when the public understands what is actually going on and what elected leaders actually stand for.

In 2018, residents told me that that they wanted better access to information about the work of Council. I observed then that a lot of conversation about local leaders and local policy was simply talking points and generalizations that were not particularly rooted in facts. Since my election, I have worked hard to help our community engage with the work of Ann Arbor City Council. I publish a newsletter to alert residents about the agenda that Council is about to vote on and I publish voting charts so our community can see how everyone voted.

I am passionate about how local democracy can work in a City like Ann Arbor: full of residents with expertise and advocates who push us toward progressive goals. As an elected leader, I look for opportunities to collaborate with residents to solve problems in our community. Expertise and advocacy from residents led me to sponsor progressive policies to expand our supply of affordable housing, protect housing supply in neighborhoods, clean up pollution in our community, increase funding for pedestrian infrastructure, protect tenants from predatory leasing practices, and develop more sustainable options for municipal power under local control.

I believe that we make better decisions around issues of controversy when our community can wrestle with the facts and consequences of policy. A core principle for me is that the connection between residents and elected leaders should be strongest at this local level. The work of your elected leaders should be most transparent at this local level, where discussion and policy

debate happens in public meetings that residents can attend, not in online forums or backrooms at City Hall. Our community deserves thoughtful and serious policy debate and to achieve that we must recognize how our democracy is supposed to work.
