Three weeks later, in 1945, the bombs were dropped, and ever since peace conscious people world wide commerate the Hiroshima and Nagasaki bombis, August 6 and 9.

These bombings have been long recognized as having had no strategic value in ending the war, where Japan was already ready for surrender. They were indeed the initiation of the war for post war dominance, giving notice to the Soviet Union that America was the new Number One. Now in the Ukraine the world holds its breath in a new mad standoff threatening mutual assured destruction.

There needs to be a turning toward peace. Let this sad occasion and the horrible "Trinity" misnomer be the stimulus here is Ann Arbor, and the still suffering of the first victims, described below.



We're writing to encourage your ongoing action, through marking Hiroshima, Nagasaki, and Trinity Day this summer.

**This particular email is about July 16: the date of the Trinity Test in 1945, when the first nuclear weapon was exploded in the USA state of New Mexico.** Wherever you are in the U.S., we hope you'll commemorate this important day in nuclear and national history. **Please look out for another email in the coming days with some specific ideas for actions you can take to commemorate July 16**, as well as a new feature on the website to report your actions and earned media.



Seven decades after the explosion, the Trinity downwinders hold a vigil in Tularosa: The names of the deceased echo across the baseball field, candles symbolize the victims.

Tina Cordova, co-founder of the [Tularosa Basin Downwinders Consortium](#), describes how, “The explosion produced more heat than the sun, and caused radioactive ash to fall for days – covering and contaminating crops, homes, bodies, and water supplies. We were innocent children, women, and men who were left to deal with the horrid consequences of being overexposed to radioactive fallout. Our families suffer from cancer, radiation-related illnesses, and early death. The people of New Mexico have been waiting over 77 years. We have never been acknowledged although **we were the original Downwinders, the first people to be exposed to a nuclear bomb and nuclear fallout anywhere in the world. We have been casualties of the U.S. government’s quest for nuclear superiority.** There is so much more to the history than what the U.S. government has been willing to share, and we were the human sacrifice.”

With the callousness that’s characteristic of nuclearism and all forms of systemic violence, the U.S. Radiation Exposure Compensation Act (RECA) - which was recently extended for two years - has never acknowledged those affected by the Trinity Test.

Given the emphasis of the TPNW on centering impacted communities, and ongoing struggles to enact and implement policies that truly attend to the widespread impacts and forms of radiation exposure, **July 16 is a day to show solidarity with those who have lost their lives, and continue to suffer, as an effect of the Trinity Test.**





Dear Dr. Corroero,

Thank you for writing. Unfortunately there can be no guarantees in this world, especially ones about curtailing obvious criminal behaviors. A city government in Michigan has limitations on what laws it can make and what actions it can take, especially when they have the potential to conflict with state or federal laws. This will not come as good news, but the laws in Michigan regarding access to firearms have been substantially weakened over the last decade. For example, it has become easier to purchase a handgun in Ann Arbor, an individual used to be required to obtain a permit to purchase a handgun prior to a sale, this process was overseen by the Ann Arbor Police Department. After the permit to purchase was obtained, there was a time limit to make that purchase and return to the AAPD to have the purchase confirmed and the serial number of the firearm registered with the city. This on top of the federally required background checks. That process is no longer required, state law has taken away that local control. This is but one example. I don't like it, and the police don't like it. I have asked them, and I have asked them the same questions you ask us. There is not a lot of good news on the front of local gun control.

In some states cities have recently started enacting various laws designed to limit access to firearms, such as requiring various insurances to possess firearms, raising the age of purchase, strengthening local "red flag" laws, and strengthening cooperation with the Federal National Instant Criminal Background Check System (NICS) to make sure that timely reporting practices are maintained. Some of these laws will pass constitutional challenges, many will not. I believe that our best hope lies with changes at the Federal level, indeed, a recent federal bill will make necessary and long-overdue changes to the NICS reporting system, among other positive improvements. I would like to see a federal reciprocity law for concealed carry permitting, combined with a federal standard for concealed carry training. I also support raising minimum age requirements for firearm purchases, across the country. What good does it do to have strict laws in one state while the state next door has lax laws? So you see why I think our best hope lies with federal change.

I'm guessing this is not the sort of answer you were hoping for, but it is a realistic one, based in experience and knowledge of the process and existing laws. For that I am sorry, but a question as serious as yours deserves a response.

Council members,

The Ann Arbor Independent used FOIA to obtain emails between Ann Arbor employees and any email address at Hooper Hathaway. The result was a 4,000 page batch of records. Among those records, are numerous emails and documents that show between January 2020 and December 2021, a partner at Hooper Hathaway negotiated on behalf of Recycle Ann Arbor to hammer out a contract with the City. Taylor voted in favor of the contract, which his firm was paid to craft, voted in favor of the contract, then signed it.

Taylor gained materially from the work of his firm. While he was claimed (without proof) that Hooper Hathaway does not share profits among its lawyers, this doesn't negate the fact that the firm's revenue benefits him personally and professionally.

Taylor's conduct is a breach of Council's Rules: Ethics, 3(a) "In regard to a contract described in subsection (2), a public servant shall not do either of the following: (a) Take any part in the negotiations for such a contract or the renegotiation or amendment of the contract, or in the approval of the contract."

Taylor voted in favor of and signed the contract negotiated by his Hooper Hathaway colleague on behalf RAA with the City of Ann Arbor.

This is a request for comment.
