Ordinance and Bylaws Amendment

As per the enabling ordinance and bylaws, the composition of the Transportation Commission includes "one owner or operator of a transportation business operating in Ann Arbor." Finding someone who fits this requirement and has interest/capacity to serve on the Transportation Commission has proven difficult in the past. At the Chair's recommendation, staff has prepared an ordinance revision and complimentary bylaws amendment which would delete this member in favor of adding an additional "member of the public" (for a total of 7). Bylaws amendments require deliberation at two Transportation Commission meetings – this will be the second meeting and the Transportation Commission can take action on this item and forward on to City Council if they so choose.

Proposed action: Recommend approval of the Transportation Commission Ordinance and Bylaws to change the membership by removing 'one owner or operator of a transportation business operating in Ann Arbor" and adding an additional "member of the public."

Capital Improvement Plan (CIP) Update

At the last meeting, the Transportation Commission reviewed a preliminary set of recommendations related to the City's CIP as prepared by Commissioners Kleinman and Houk. Staff worked with Commissioners Kleinman and Houk to refine the recommendation and organize them under the headers of: CIP Projects; Project Evaluation and Selection Process; Project Funding and Budget; and Policy Recommendations.

Proposed action: Recommend approval of the Transportation Commission's recommendations for the CIP and related processes.

Seventh and Greenview Project

The City is currently in the process to determine the design for the Seventh and Greenview project. Included in the packet is a presentation which will be reviewed by City staff. The Transportation Commission will be asked for feedback and possibly a recommendation on the preferred alternative – one concept would require removal of on-street parking which would in turn require action by City Council. Note the public engagement for this project will be open until the day before the Transportation Commission meeting so new information may come after packet distribution based on the input received. Proposed action: Provide feedback on the Seventh/Greenview concepts. If parking removal is preferred among the Transportation Commission, this recommendation should be explicitly made so that it can be forwarded to Council.
