

On Mon, Jan 9, 2023 at 12:51 PM wrote: Dear Neighbors, Maris suggested I also contact the police about arranging a meeting with an assigned officer and ourselves. She is right. The more of us call in, the more we convey the urgency and seriousness of the situation and get action. This morning I contacted the police and was refered to Sgt. Mark Pulford. I'm waiting a return call. I'll be a squeaky wheel about this. I personally have not had anything stolen — just Letha panhandling. But it's a matter of time before something goes missing from my property too.

I've made all addressees public here in this email and ask that addresses and names be kept confidential among this group — and shared only with other neighbors you know that need to be included. This is not a complete listing of those who may be affected by Letha's stealing. You can recognize neighbors and please, if you note some that are missing, please ask them to be part of this. I don't have email for Nate, Matt, or the renters btwn their houses and renters in the Lund House property. If you have renters, please also include them on this list. I'll be doing my best to contact those I know who live in close proximity to Avalon.

We all miss Sarah for many reasons. One of those was that she was our neighborhood 'captain'. If anyone has an interest in taking that on, please let us know.

A couple people have brought up the urgency of taking action. We are in the time of year when tax info comes by mail as does tax refund checks. Also consider MI drivers' licenses, license registration, and license tags and even passports. Loss of any of the above is more than just an aggrevation. It's a federal offense to tamper with mailboxes.

Please keep an eye on your emails with a proposed meeting date. I'm happy to offer my studio where there should be ample seating for everyone. We'll try to schedule this in the evening. In preparation for this meeting, please compile a detailed list of any theft or attempted theft you've experienced. You can bring this to the meeting, give it to a neighbor (if you can't attend), or forward to me.

What we need are accounts of:

Letters you suspect were stolen or if you found your mail thrown in nearby woods/property.

Packages you suspect were stolen or if you found remnants on nearby property.

Vido you have of Letha tampering with your mailbox, attempting to enter a car, approaching a house for money, taking a package from your door.

Instances where you found her, unininvited, in or on your property whether it was to ask for money or where it appeared she was looking around for things of value.

Times/places/and frequency of her asking you for money. Panhandling isn't illegal, but the sheer volume of it and any aggressive panhandling on her part needs to be noted.

If this continues to be a problem noted by only one person at a time, and the rest of the neighborhood is unaware of the extent, nothing will happen. We've seen that. If we, as a neighborhood, present this as a group, then we have a much better chance of affecting change. Avalon, unfortunately, has been less than effective at returning any of our calls or curbing Letha's behavior.

We certainly have empathy for Letha and her situation. We also must consider the toll taken on each and every one of us when our homes and cars are violated as they are. Hoping this will go away by itself isn't going to make it so.

Maris, thank you for starting the conversation and helping to make more of us aware of the extent of the problem.

Hi Neighbors,

I just got off the phone with Officer Doug Martell from the A2PD Community Engagement team, and Tara Tarbox from Avalon Housing, and had fairly long conversations with both of them about what the problems have been, not only recently with Letha but in the past as well, including problems with noise, trash, panhandling and trespassing.

Officer Martell said panhandling was not illegal, as long as it wasn't deemed "aggressive", meaning the panhandler can't get within 2 feet of you and can't continue once you've expressed any sign that you don't want to engage with them. They can panhandle in the street or on the sidewalk, but cannot set foot on private property. He also said that the police dept has a regular, twice monthly Thursday meeting with Avalon to discuss problems with their residents/buildings and they are meeting tomorrow. I expressed our concerns about why Letha's condition (drug abuse, poor health) were not addressed earlier when it was so obvious. And he said he would bring that up at the meeting tomorrow.

With Tara at Avalon I told her the same. We are all wondering why it came to this with Letha, when it was our understanding that the Avalon residents had people looking out for their well-being. And when Letha has been so obviously in bad shape physically and mentally since at least last spring. Tara apologized and admitted that Avalon had dropped the ball in Letha's case. There were "many missed meetings" with her Support Coordinator who might have gotten her some help, so they weren't aware of how bad off she was. Also, the neighbors who were calling to report Letha's behavior didn't know her name and so Avalon staff wasn't sure who it was. Now they have put 2 and 2 together, with Chang's video of the theft and our reports in the last couple of days.


Both Officer Martell and Tara Tarbox said they would be discussing our concerns about the Pear St. Avalon residents and their supervision at tomorrow's meeting. I asked them both to arrange and facilitate a meeting between us neighbors and the Avalon officials and the Police department, so that we can discuss with them our expectations of them and what their plans are for correcting these problems.

Tara agreed that January sometime would be best for meeting, since the holidays are coming up, and she will be in touch with me about that soon, along with info about what if anything comes out of the meeting tomorrow with the police department.

I also mentioned to Tara that if they expect the proposed new Avalon residence adjacent to the Farmer's Market to be successful, they need to find solutions to these problems soon, or they will become an even bigger problem in that busy location. She agreed with that as well, and said she would pass on everything from our discussion to the Powers That Be at Avalon, and at the meeting with the police tomorrow.

Thanks to all of you who contacted Avalon in the last couple of days and especially to you Chang, for being so gracious and helpful with Letha. Let's all keep our fingers crossed for Letha that she gets all the help she needs and recovers.

I am the person whom she stole from. I got in contact with Avalon's manager, and luckily got most of the stuff back. If you also lost a package recently, contact Avalon's management teams, there's still a chance to get them back before they are resold. Avalon's manager is very nice and helpful. They said they received multiple complaints about her today, and the behavior has been out of line. They arranged a meeting with her, and she agreed to start treatment next Monday. Our voice has definitely been heard and we are withdrawing our previous police report.

On the other note, I really appreciate this neighborhood. Everyone has been super kind and thoughtful. I hope that we all have a nice winter holiday this year!

I also just left a vm with Sgt. Mark Pulford with the **Community Engagement Unit** of the Ann Arbor Police. I asked him if he could facilitate a meeting between us neighbors and Avalon. Maybe he will have better luck getting a response from them. I think Avalon needs to know we don't mind having them as a neighbor as long as their tenants are well supervised and get the help they need. Clearly that has not been happening. It was my understanding that helping their residents in general was Avalon's mission, not simply providing a roof over their heads.

Your input on this would be much appreciated, and I will let you know what hear from Avalon and Sgt. Pulford.

And yes Sarah was our Neighborhood Watch liaison, as far as I know, but I hadn't received any info from her in a few years. Does that program even still exist? Perhaps that's something to discuss with Sgt. Pulford as well. Anyone want to volunteer to take over that job? I can't do it, but I think it mainly involves forwarding emails to us all about problems in the neighborhood, such as this one with Letha.






