Leslie, are you saying that we should coordinate a Q&A with the analysts to determine their goals in seeking our consultation? Isn't it likely that the same participants (from Detroit and the HRC) will attend the Q&A as attend the ultimate meeting? I would prefer one meeting and engage in an open and transparent discussion concerning the help they seek and the systems we have in place. When I worked with Detroit (analysts, aides, Council Members) on the enactment of their local government ID, they asked us to walk through the rationale that underlay the policy and the legal questions they should prepare to answer. Yes, we were asked to attend a number of meetings with different wings of City government and invariably we needed to answer questions very similar to questions we answered in prior weeks, but it was explained to me that decision makers in Detroit like to hear from and personally question the original sources of the information they find relevant.

What goals might the analysts have that would represent an inefficient use of our time? If my experience is any indication of what may be required of us if we are to help Detroit enact a Fair Chance Ordinance I don't think efficiency can be our guiding standard. Rather I think we should be guided by the needs of the residents of Detroit. Just as we believe this Ordinance important for Ann Arbor it's as important if not more so for Detroit.

Let's not place conditions on our help. Let's signal instead that no question is too basic and we feel strongly that Fair Chance Housing is needed everywhere and absolutely should be enacted in Detroit. We can of course explain that Margie as a City Attorney will most likely not be as freely available.

It's mostly been a question of potential tenants contacting us to say the landlord is violating the ordinance and then we call the landlord and educate them about the ordinance.
