At the same time that U.S. workers stagger unprotected under loss of wages, benefits, and jobs, weakened by the lowest rate of unionization in decades, in China, workers--many of them teenage student interns--mount tens of thousands of wildcat strikes each year, defying capital, the state and the Trade Union.

The effects on workers of global capitalism's latest project--in China--are now emerging into light with the wave of automobile strikes that shook the country last summer.

How can we make sense of what is happening in China? The ACFTU (All China Federation of Trade Unions) is the largest union on the planet, but one which does no collective bargaining and doesn't represent workers. The central government has embraced neoliberal economics as fiercely as any country on earth, yet behaves as the "payer of last resort" when private employers default on wages.

Contradictory pressures are driving new labor conflicts; are new forms of worker self-organization coming to birth?

Ellen David Friedman has been a union organizer and labor educator in Vermont since the mid-1970s, including 20 years with the National Education Association. Starting in 2003 she began working in China, and--since 2005--spends one academic term per year teaching labor studies at Sun Yat-sen University in Guangzhou and working closely with the Guangzhou Federation of Trade Unions, grass-roots labor NGOs, students and scholars. She also organizes exchange study tours between U.S. and Chinese labor leaders and academics.

Polls: Wisconsin Voters Diss Walker's Mess

Evan McMorris-Santoro's report at TPM on new polls of Wisconsin voters, conducted by GQR Research for the AFL-CIO 2/16-20 should give the demonstrators some encouragement in their struggle against Gov. Walker's union-busting. McMorris-Santorro explains,

Sixty-two percent of respondents to the poll said they view public employees favorably, while just 11% said they had an unfavorable view of the workers whose benefits packages Walker says are breaking the state budget.

Meanwhile, just 39% of respondents had a favorable view of Walker, while 49% had an unfavorable view of the freshman Republican governor. Voters are split on his job performance, with 51% saying they disapprove of the job Walker has done.

As the GQR pollsters explain in their analysis, "Since the protests began, Governor Walker has seen real erosion in his standing, with a majority expressing disapproval of his job performance and disagreement with his agenda." And when read the following description of the conflict in Madison, 52% of respondents said they don't favor Walker's scheme, with just 42% favoring it:

As you may know, Governor Scott Walker recently announced a plan to limit most public employees' ability to negotiate their wages and benefits. The plan cuts pension and health care benefits for current public workers, and restricts new wage increases unless approved by a voter referendum. Contracts would be limited to one year, with wages frozen until a new contract is settled. In addition, Walker's plan also changes rules to require collective bargaining units to take annual votes to maintain certification as a union, stops employers from collecting union dues, and allows members of collective bargaining units to avoid

paying dues. Law enforcement, fire employees and state troopers and inspectors would be exempt from the changes.

...Which underscores the importance of unions telling their side of the story. The survey also found that 53 percent of voters rate unions favorably, with only 31 percent rating them unfavorably. Of those polled, 67 percent said they sided with the public employees, 62 percent with the protesters, 59 percent with the unions and 56 percent with Democrats in the state legislature.

A majority, 53 percent, disagree with Governor Walker and 46 percent disagree with Republicans in the state legislature.

When asked, 58 percent of respondents oppose eliminating collective bargaining, 57 percent oppose cutting wages for public employees and half are against cutting pension benefits for public employees.

Independents (59 percent) don't like it much, either, nor do a third of Republicans, along with 78 percent of Democrats. Three out of four respondents said they opposed taking away public employees' collective bargaining rights, including nearly half of Republicans.

It appears Governor Walker may have succeeded in currying favor with the Koch brothers. But Wisconsin voters are unimpressed with his polarizing attack against state workers.

Union supporters in Wisconsin are pointing to a new poll they say shows support for Gov. Scott Walker (R) is straining under the weight of the thousands of protesters gathered in and around the state capitol in Madison.

The poll of Wisconsin voters, conducted by Democratic pollster GQR Research for the AFL-CIO between Feb. 16 and 20, shows public feelings toward the union supporters versus the Republican governor are vastly different.

Sixty-two percent of respondents to the poll said they view public employees favorably, while just 11% said they had an unfavorable view of the workers whose benefits packages Walker says are breaking the state budget.

Meanwhile, just 39% of respondents had a favorable view of Walker, while 49% had an unfavorable view of the freshman Republican governor. Voters are split on his job performance, with 51% saying they disapprove of the job Walker has done.

"Since the protests began, Governor Walker has seen real erosion in his standing," the GQR pollsters write in their analysis, "with a majority expressing disapproval of his job performance and disagreement with his agenda."

Other questions from the poll show that when given a detailed description on the current dispute between labor and the Republicans in Madison, Wisconsin voters tend to side with the unions. Here's what the detailed question in the AFL-CIO-sponsored survey sounded like:

Bahrain - An Uprising on the Verge of Revolution

The protesters who are calling for an end to royal rule are in no mood to compromise

Bahrain is not Egypt. Bahrain is not Tunisia. And Bahrain is not Libya or Algeria or Yemen. True, the tens of thousands gathering again yesterday at the Pearl roundabout - most of them Shia but some of them Sunni Muslims - dressed themselves in Bahraini flags, just as the Cairo millions wore Egyptian flags in Tahrir Square.

But this miniature sultanist kingdom is not yet experiencing a revolution. The uprising of the country's 70 per cent - or is it 80 per cent? -Shia population is more a civil rights movement than a mass of republican rebels, but Crown Prince Salman bin Hamad al-Khalifa had better meet their demands quickly if he doesn't want an insurrection.

Indeed, the calls for an end to the entire 200-year-old Khalifa family rule in Bahrain are growing way ahead of the original aims of this explosion of anger: an elected prime minister, a constitutional monarchy, an end to discrimination. The cries of disgust at the Khalifas are much louder, the slogans more incendiary; and the vast array of supposedly opposition personalities talking to the Crown Prince is far behind the mood of the crowds who were yesterday erecting makeshift homes - tented, fully carpeted, complete with tea stalls and portable lavatories - in the very centre of Manama. The royal family would like them to leave but they have no intention of doing so. Yesterday, thousands of employees of the huge Alba aluminium plant marched to the roundabout to remind King Hamad and the Crown Prince that a powerful industrial and trade union movement now lies behind this sea of largely Shia protesters.

Yet Crown Prince Salman talks more about stability, calm, security and "national cohesion" than serious electoral and constitutional reform. Is he trying to "do a Mubarak" and make promises - genuine ones for the moment, perhaps, but kingly pledges do tend to fade with "stability" and time - which will not be met?

In an interview with CNN, he acknowledged the Belfast parallels, exclaiming that "what we don't want to do, like in Northern Ireland, is to descend into militia warfare or sectarianism". But the crazed shooting of the Bahraini army on Thursday evening - 50 wounded, three critically, one already pronounced brain dead - was a small-size Bloody Sunday and it didn't take long for the original civil rights movement in Northern Ireland to be outrun by a new IRA. Clearly, the royal family has been shocked at the events of the last week.

Sultan al-Khalifa's admission that "this is not the Bahrain I know, I never thought I would see the day that something like this would happen" proves as much.

But his words suggest that this huge manifestation of public fury was merely provoked by television pictures of the Tunisian and Egyptian revolutions. For the record, the Shia rebellion against the country's Sunni rulers has been going on for years, with hundreds of political prisoners tortured in four prisons in and around Manama, their tormentors often from the Jordanian army - just as many Bahraini soldiers come from the Punjab and Baluchistan in Pakistan. Yesterday, there were repeated demands for the release of political prisoners, banners carrying photographs of young men who are still in jail years after their original sentencing: they run into the hundreds.

Then there are the disturbing stories of the refrigerated trucks which reportedly took dozens of corpses for secret burial, perhaps in Saudi Arabia.

These could be part of the carapace of rumour that has settled over the events of the past few days, but now some of the names of the disappeared - men who were present at the shootings near the Pearl roundabout last week - are known.

Twelve of their names have just been released. So where is 14-year-old Ahmed Salah Issa, Hossein Hassan Ali, aged 18, Ahmed Ali Mohsen, 25 and Badria Abda Ali, a woman of unknown age? And where is Hani Mohamed Ali, 27, Mahdi al-Mahousi, 24, Mohamed Abdullah, 18, Hamed Abdullah al-Faraj, 21, Fadel Jassem, 45, and Hossein Salman, 48? English residents of a nearby apartment block were warned before the shooting that if they took photographs of the soldiers, they would be shot.

Matar Ibrahim, one of 18 Bahrain Shia MPs, agrees that there is an increasing gap now between demonstrators and the official political opposition that is being sought out by Crown Prince Salman.

"We are waiting for an initiative from the Crown Prince," he told me. "He has not mentioned reform or constitutional monarchy and a fully elected parliament.

If people have a properly elected government, including the prime minister, they will blame their representatives if things go wrong. Now, they blame the King.

"What we are suggesting is a removal of the barriers between the people and the ruling family. When Hillary Clinton came to Bahrain, I told her that we don't want to see the US 5th Fleet in Bahrain [its military headquarters] as an obstacle to change, but currently, Bahrain is the worst strategic ally for the US."

The head of the Alba factory trade union, Ali Bin Ali - who is a Sunni - warned that his members could go on strike if they wanted to. "Now that people have been shot down on the roads, we will be political," he said.

Which, of course, is not what the Crown Prince wants to hear.

State Senator R.C. Soles (D - NC) Long time Anti-Gun Advocate State Senator R.C. Soles, 74, shot one of two intruders at his home just outside Tabor City, N.C. about 5 p.m. Sunday, the prosecutor for the politician's home county said.

The intruder, Kyle Blackburn, was taken to a South Carolina hospital, but the injuries were not reported to be life-threatening, according to Rex Gore, district attorney for Columbus, Bladen and Brunswick counties.

The State Bureau of Investigation and Columbus County Sheriff's Department are investigating the shooting, Gore said. Soles, who was not arrested, declined to discuss the incident Sunday evening. "I am not in a position to talk to you," Soles said by telephone. "I'm right in the middle of an investigation."

The Senator, who has made a career of being against gun ownership for the general public, didn't hesitate to defend himself with his own gun when he believed he was in immediate danger and he was the victim.

In typical hypocritical liberal fashion, the "Do as I say and not as I do" Anti-Gun Activist Lawmaker picked up his gun and took action in what apparently was a self-defense shooting. Why hypocritical you may ask?
