# PARTNERS IN ACCESS: COMMUNITY ENGAGEMENT & RECRUITING ACTIVITY - ALEX GOSSAGE, RACHEL HAWKINS AND LARRY KEELER

L. Keeler discussed amending CODI's bylaws regarding Article 9, Section 3 which involves recruiting. Presently, this section of the bylaws are not well understood and would like to rewrite a more clear recruiting outline process for future commissioners reference R. Hawkins added the recruiting process will be more beneficial if it was more standardized.

Ann Arbor Inclusive; R. Hawkins reported a new show will premier on Friday, April 21, 2023 at 4:30 p.m., on CTN and their YouTube channel.

Their quest will be the Mind Center of Farmington Hills.

Alex Gossage reported on the Downtown Stakeholder Letter regarding Downtown Public Bathrooms, since Downtown has no public bathrooms the City thinks it has a solution with the Throne an ADA accessible unit. Commissioners will receive a copy of the Downtown Stakeholder letter to review and PIA will discuss at their next meeting. Any suggestions or concerns please email PIA commissioners, A. Gossage, R. Hawkins and L. Keeler. A community member reached out concerning construction on Maple and Scio Church that the sidewalks were not complete or accessible. The PIA will keep up with summer construction and encourage if you notice any irregularities, please bring them to our attention.

L. Keeler reported on our current recruiting status. The commission possibly have two new applicants.

### TRANSPORTATION COMMISSION UPDATE - LARRY KEELER

L. Keeler provided an update on the Transportation Commission. Last month there were more debates over sidewalks around the Earhart Village. E-Bikes are returning and taken over by Spin. Crosswalk guidelines were developed in 2015, CODI was acknowledged in the development of some of those guidelines. They will tweak them to reflex today's environment. They are still trying to take care of sidewalks gaps in the City that don't have a connection and construction to correct the problem. More bike corrals are going downtown.

# U OF M COUNCIL FOR DISABILITY CONCERNS MEETING UPDATE - MATTHEW SOLOMON

M. Solomon provided an update on the Council for Disability Concerns. He reminded us if any commissioners are interested in the monthly CfDC meetings held on zoom, please sign-up for the emails to be informed about all the activities. This month's presentation was by Allison Kushner who is the Director of Disability, Equity and ADA Coordinator (note: this title language may be relevant to our upcoming position). Including an introduction from the Equity Civil Rights & Title IX office: Megan Marshall, Deputy ADA Coordinator, Phil Deaton, Digital Information Accessibility Coordinator, Sarah Caruso, Administrative Specialist in ECRT and Stephanie Beatty, ASL Interpreter. University of Michigan is investing in this area, these resources have seen a growth over the last six months.

### **DIRECTOR OF ORGANIZATIONAL EQUITY - LAURA ORTA**

Laura Orta provided an update on the Accessibility Coordinator Position. The job description is ready to be sent forward to legal. If commissioners have any additional suggestions, comments or concerns, please send them to Lara by Wednesday, April 26, 2023 a copy will be sent to legal by the end of next week. A copy of the Accessibility Coordinator Position Draft will be sent to commissioners. L. Orta wants to ensure that this position has positive outcomes and tie them back to what the individual is doing and how they are making a difference in our community. This way we can monitor to make sure the City is filling the gaps or we need to consider changing the job description or adding to the team. She suggest that commissioners and the community use the City's A2FIXIT app it is an excellent way to communicate with City departments to report problems in the community.

Proposing to write an amendment to the bylaws; Article 9, Section 3 to provide a clearer understanding of the recruitment process. Applicants would be interviewed by PIA initially, then invited to a full commission meeting (public comment) to ensure complete transparency. And all commissioners will have access to new commissioners applications. R. Hawkins noted our goal was to keep the commission updated, there is nothing definitive at this point. Currently we have a rough outline to review and to process until the commission votes otherwise. PIA will revive the language after your review and present again in May. ### CITY COUNCIL UPDATE

CM A.G.Edwin gave an update on accessibility. Main Street closing for the summer and several adjacent streets. She is working with the DDA to allocate more accessible parking spaces adjacent to the closures. The city has approved three parking spots. Working on integrating accessible paths into our maps online so people with disabilities can plan their trips in advance to ensure accessible routes are available. She will keep the commission updated. To recap on the Downtown bathrooms, she has reached out to City Administrator, Milton Dohoney every Throne bathoom units will be accessible and gender inclusive. The placement

will have to do with infrastructure, electricity and sidewalks. The City Administrator is supportive of CODI being involved in the process.
