### Granger (Forest to Olivia) Traffic Calming

The petition process for Granger Traffic Calming between Forest and Olivia is now complete. Final polling showed support for the proposed project among the respondents, so it is coming to the Transportation Commission for a recommendation before going to City Council in July. ### Safe Streets for All Grant Agreement

It was announced earlier this year that the City of Ann Arbor was chosen by the US Department of Transportation Federal Highway Administration (FHWA) to receive a Safe Streets for All Grant award (<https://www.transportation.gov/grants/SS4A>). The partial award of \$3.8 million (requiring a local match of \$950,000) will fund three elements of the City's application: Speed Management Program; Quick Build Projects; and Near Miss Analytics. After months of discussion on the particular details, City and FHWA staff have drafted a grant agreement which is acceptable. Staff seek a recommendation from the Transportation Commission before bringing this item to City Council in July.

*Proposed Action: Make a recommendation on the Safe Streets for All Grant Agreement*

### Enforcement of Secondary Offenses

Councilmember Cynthia Harrison will discuss a policy that is being considered that would restrict secondary offenses as a means by which the Police Department would initiate a traffic enforcement stop.

**Treeline Trail Update**

The Treeline Trail is a proposed urban trail that will provide safe, non-motorized travel to many of Ann Arbor's cultural and recreational sites and connect with the county-wide Border-to-Border Trail and the state-wide Iron Belle Trail. The vision for this trail is outlined in the adopted Treeline Master Plan (<https://www.a2gov.org/treeline>). The City is working with the Treeline Conservancy (<https://thetreeline.org/>) and others to move the Plan and coordinating projects towards realization. The Conservancy is actively raising funds to design and construct the trail and has had some success advancing segments of the Treeline. Representatives from the Conservancy will give a presentation on their efforts.

**Staff Report and Updates**

The monthly transportation progress report is included and will be reviewed by staff. Included in the attachments is a new report produced by the Police Department on the number of citations issued to motorists parking in bike lanes.
