As a resident since 2003 at Earhart Village condominiums, I would like to express my concerns about the above referenced project being planned by the City of Ann Arbor Planning Commission. We have been informed by the commission that this project, scheduled to be underway sometime the summer of 2023, will involve closing all lanes of Earhart Road, with the exception of one northbound lane, for all traffic during construction. Earhart Village Condominiums are located on semicircular Greenhills Drive and Earhart Road with no other roadway entrance or exits available. In addition, within the proposed construction zone, there are other subdivisions, elementary schools, Greenhills private school and Glacier Hills retirement and convalescence center accessed by Earhart Road. Furthermore, Earhart Road is a major connection route between Geddes and Plymouth Road with off/on ramp traffic from north and southbound US23, also being heavily utilized by the employees of University of Michigan, UMHS, Concordia and WCC. Under the proposed city plan, how can emergency response vehicles possibly provide life saving emergency services during construction, as needed by the residents of Earhart Village Condominiums and other subdivisions, students/employees of educational institutions, and medical/support staff commuting to and from
