1. Brandon Dimcheff - 1601 S. State St. Rezoning (C-1); Home Energy Rating Disclosure (HERD) Ordinance (C-3) (phone)

Brandon Dimcheff, resident, spoke in support of C-1 and C-3.

2. Edward Vielmetti - TC1 Amendments (C-2) (in person)

Edward Vielmetti, resident, spoke in opposition to the proposed changes to C-2 and the TC-1 zoning. He expressed opposition to changes that promoted car dealerships and car-friendly policies.

3. Kathy Griswold - Resolution Regarding Pavement Marking Maintenance (CA-5); Pedestrian Safety & Maintaining the Right-Of-Way (phone)

Kathy Griswold, resident, expressed concerns about pedestrian safety policies, including overgrown vegetation in the rights-of-way.

4. Tom Renkert - Home Energy Rating Disclosure (HERD) Ordinance (C-3) (in person)

Tom Renkert, representing local real estate agents, spoke in opposition to the proposed ordinance, item C-3, regarding Home Energy Rating Disclosure. He stated this proposal unfairly targets those buying and selling homes and will slow down and delay home sales.

5. Monica Swartout-Bebow - Resolution Regarding a New Club Liquor License for Kerrytown Concert House (DC-2) (in person)

Monica Swartout-Bebow, representing the Kerrytown Concert House, spoke in support of the Concert House's application for a Club liquor license.

6. Alex Lowe - Resolution to Approve the Purchase of a Towable Woodchipper from Bandit Industries Inc (CA-10); TC1 Amendments (C-2) (phone)

Alex Lowe, resident, expressed concerns about the City purchasing gas-powered equipment and machines, in opposition to the City's A2Zero goals. He also spoke in opposition to the proposed changes to the TC-1 zoning.

7. Thomas Stulberg - 1601 S. State St. Rezoning (C-1) (phone)

Thomas Stulberg, resident, spoke in opposition to C-1, the 1601 S. State Street rezoning.

8. Dyani Sabin - Renters Issues (in person)

Dyani Sabin, resident, spoke about tenant issues in Ann Arbor, including the condition of the units and the high cost of rent compared to other college towns.

9. Claire Arneson - Rights of Tenants (phone)

Claire Arneson, resident, spoke about being a tenant of McKinley Properties. Her concerns include the rising cost of rent and substantial rental increases each year. She stated the new ordinances have not addressed wait list fees and other costs.

10. Henry Herskovitz - Holocaust Education in AAPS (in person)

Henry Herskovitz, resident, spoke about Holocaust education and curriculum in the Ann Arbor Public Schools.

11. Eimo Kaku - Rent Control (in person)

Eimo Kaku, resident, spoke about rental housing concerns in Ann Arbor.

12. Jennifer Sparks - Tenant Protections in Ann Arbor (in person)

Jennifer Sparks, of Pittsfield Charter Township, spoke about rental conditions and the cost of rent in McKinley Properties throughout the Ann Arbor area.

13. Justin Yuan - Non-Refundable Fees in Tenant Applications (phone)

Justin Yuan, of Pittsfield Charter Township, spoke about the high-rate of rent in Ann Arbor and urged Council to prohibit non-refundable fees, such as wait list fees.

14. Mira - General Comments

15. Serge Vandervoo - Concern Regarding the Intersection of N. 5th Ave. and Catherine St. (in person)

Serge Vandervoo, resident, spoke about his concerns regarding the bike lane and vehicular intersection at Catherine Street and Fifth Avenue. He urged the City to review this design, noting that he recently hit a bicyclist when making a left turn.

16. Faith Redwine-Otieno - Michigan Tenants Assembly (in person)

Faith Redwine-Otieno, resident, shared her concerns about renting in the Ann Arbor area.

17. Jessica Prozinski - Housing Concerns

Jessica Prozinski, resident, shared her concerns about renting in the Ann Arbor area. She stated the quality of the living situation does not match the high rate of rent in the area.
