# **Traffic Calming Program**

The Transportation Commission established the <u>Traffic Calming Committee</u> in August, 2022. Since then, staff and the Committee have met several times to see if improvements could be made to the existing program. The Transportation Commission reviewed a <u>draft resolution and back-up materials</u> for a revised Traffic Calming Program at their May meeting – at which time the Commission referred the item back to the Committee for further revisions. The Committee has drafted a revised resolution for the Transportation Commission's consideration which is included in the packet.

### **Ordinance and Bylaws Amendment**

The Transportation Commission voted to <u>change its bylaws in September 2022</u> by replacing "one owner or operator of a transportation business operating in Ann Arbor" with an additional "member of the public" (for a total of 7). Ordinance and Bylaws Amendments need to be approved by City Council. At the second reading of these proposed changes on August 7, 2023, Council voted to postpone action so that the Transportation Commission may consider reserving a seat on the Commission for someone 55 years of age or older. Upon the Transportation's Commission's consideration and recommendation, City Council will take up the item again at their meeting on September 18, 2023.

Proposed action: Take action on whether the Bylaws should reserve a seat on the Commission for someone 55 years of age or older

## **Transportation Asset Management Plan**

A Transportation Asset Management Plan Update and Resolution will be considered by City Council at the September 5, 2023 meeting (here is a link to the 2020 Plan for context). This is primarily an administrative exercise to fulfil the requirements of Public Act 325 of 2018 to submit an updated plan to the State by October 1, 2023. The plan focuses on condition and management of our transportation assets, with a primary focus on pavement condition. The plan includes a discussion of current and forecasted pavement condition, as well as the City's goals in that area, all of which can be found on the Roads dashboard at <a href="https://www.a2gov.org/a2streets">www.a2gov.org/a2streets</a>.
