CITY OF ANN ARBOR AMENDMENT NUMBER 1 TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN ROWE PROFESSIONAL SERVICES COMPANY INC AND THE CITY OF ANN ARBOR FOR ENGINEERING SERVICES

This Amendment Number 1 ("Amendment") is to the agreement between the City of Ann Arbor, ("City") and ROWE PROFESSIONAL SERVICES COMPANY INC, ("Contractor") for Professional Services Agreement (PSA) which is dated 12-28-2020 ("Agreement"). City and Contractor agree to amend the Agreement as follows:

1. Article II, DURATION is amended to read as follows:

Contractor shall commence performance on October 1, 2023 ("Commencement Date"). This Agreement shall remain in effect through December 31, 2024 unless terminated as provided for in Article XI. The terms and conditions of this Agreement shall apply to the earlier of the Effective Date or Commencement Date.

2. Article V, Section A COMPENSATION OF CONTRACTOR is amended to read as follows:

A. The Contractor shall be paid in the manner set forth in Exhibit B. Payment shall be made monthly, unless another payment term is specified in Exhibit B or applicable Work Statement, following receipt of invoices submitted by the Contractor, and approved by the Contract Administrator. The total fee to be paid Contractor for services shall not exceed \$331,000 for the duration of the Agreement.

All terms, conditions, and provisions of the Agreement, unless specifically amended above, shall apply to this Amendment and are made a part of this Amendment as though expressly rewritten, incorporated, and included herein.

City and Contractor agree that for this Amendment and any documents related to the Agreement:
1) signatures may be delivered electronically in lieu of an original signature; 2) to treat electronic signatures as original signatures that bind them; and 3) signatures may be executed and delivered by facsimile and upon such delivery, the facsimile signature will be deemed to have the same effect as if the original signature had been delivered to the other party.

This Amendment to the Agreement shall be binding on the Parties' heirs, successors, and assigns.
