

Dear Administrator Dahoney and Asst. Admin. Fournier, Mayor Taylor and Council Members,

I have read the RFP for an unarmed crisis response program. I am very pleased with many of the features to be included. I would like to share some personal reflections on desirable aspects of such a program in hopes they help inform your evaluation of the proposals you receive.

When I think about safety for all in our community, I ask myself what creates safety? This is not simply a matter of "hiring the right people and holding them accountable." Public safety embodies a long-term commitment of Ann Arbor, as a community, to care for each other. We are acknowledging responsibility for the well-being of all who live here. It is a commitment from the community to the community, not something we "outsource" to a program designed without our voice or engagement. Knowing the full range of this community and its character and needs is critical. I hope for a real connection to the residents of Ann Arbor from the outset.

I feel having its roots in Ann Arbor will equip a program to evolve organically and remain flexible since it will not be based on an external template projected onto this community. It is also open to the involvement and social investment of the local residents. I am concerned that delegating fulfillment of our needs to outside "experts" invites the kind of painful disconnect we experienced with the vision of the firm that proposed a design for our independent police oversight commission. A locally created program is not generic and not intended to fit various parameters of size, scale, demographics, priorities, etc.

I hope there will be several promising proposals and that city staff and Council can identify which is most likely to provide the program that best fits our needs for the long term. I appreciate the considerable time and thought that have gone into getting us this far.
