PARCEL 1:

THE NORTHWEST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 32, T2S, R6E, CITY OF ANN ARBOR, WASHTENAW COUNTY, MICHIGAN; EXCEPTING THAT PORTION USED FOR HIGHWAY PURPOSES; FURTHER EXCEPTING PORTION CONVEYED IN LIBER 2896, PAGE 678, WASHTENAW COUNTY RECORDS.
