Please see attached REVISED renewal letter from Terry Baker, Client Relationship Specialist, correcting the amount of the AWN fee for Ann Arbor's September 2022 annual renewal. Ann Arbor only has 5 DCU's using the AWN Cellular service. The attached letter does include the 5% escalation that is stipulated in the maintenance agreement. The AWN fee of \$1,512 on the attached revised renewal letter is strictly just for the period of Sept 1, 2022 – Aug 31, 2023. Once the amendment is signed, Ann Arbor will also be billed for the months of service already received but not billed due to the lack of a signed agreement. Once the Amendment is signed by both parties, Ann Arbor will also be billed the following for AWN service already used. The escalation is not being charged on the past billing that did not occur due to the lack of the fully executed amendment.
