#### **HOW TO CALCULATE TAXES OWED FROM MILLAGE RATES.**

1 MILL = .001 or 1 MILL = 1 PER 1000 TAXABLE VALUE

EXAMPLE: IF YOUR TAXABLE VALUE IS \$100,000

Your home is located in the City of Ann Arbor with a millage rate of <u>18.3888</u> This millage is <u>ONLY</u> the City portion. Use this example to compute any millage.

NOTE: Some communities levy one half their millage in the summer and the other half in the winter.

Villages levy their millages only in the summer.

Some schools levy all their millage in the summer only

#### **HOW TO CALCULATE TAXES OWED FROM MILLAGE RATES.**

1 MILL = .001 or 1 MILL = 1 PER 1000 TAXABLE VALUE

EXAMPLE: IF YOUR TAXABLE VALUE IS \$100,000 IN THE CITY OF ANN ARBOR

FORMULA: TAXABLE VALUE X MILLAGE RATE 1,000




