Moved by Goode, seconded by Tibbits, to approve the Resolution to Requests that the Ann Arbor City Council Pursue a Phase 2 Study for the Municipalization of the Power Grid.

Whereas, the consumers in Ann Arbor have some of the most expensive and dirty electricity in the na on and also some of the worst reliability rates.

Whereas, extreme weather events o □en cause outages, extreme weather is worsened by DTE's contribu □on to greenhouse gases and Ann Arbor has a stated goal of becoming carbon neutral. Whereas, electrical outages are more and more common in Ann Arbor and their impact is more dire for renters than homeowners due to:

• the fact that stals cally renters are lower income than homeowners, therefore the loss of medicine, perishable food and the ability to eat healthily during an outage is a greater hardship on renters,

• the inability of renters to install generators or solar panel systems to help endure outages as many homeowners have done,

• fewer renters owning cars than homeowners making it more difficult to evacuate or temporarily move out during an outage than homeowners who can pack up the car with kids, medical supplies and food and head to friends, family or hotels in a neighboring community, and

• homeowners con a use to gain equity in their home during an outage while renters must pay rent on a par ally usable or not at all usable units during an outage.

Be it recognized that changing to a publicly held electric company would not solve all financial difficul □es facing Ann Arbor renters it would ease the housing burden many face.

Resolved, the Ann Arbor Renters Commission requests that the Ann Arbor City Council pursue a Phase 2 study for the municipaliza on of the power grid and all other means available to ease the burden renters face due to unreliable electricity.

Proposed amendments must have been submitted in writing at the previous regular meeting to be considered. Proposed amendments must be submitted to the Office of the City Attorney for review prior to adoption by the Commission. After adoption by the Commission, the bylaws are not effective until approved by City Council.

11.2 These bylaws shall be reviewed annually by the Commission for possible amendment."
