## Follow Up on Outside Group Work

City Council Updates - CM Song: CM Song reported that City Council is working on zoning changes for affordable housing in the City of Ann Arbor. Ann Arbor Housing Commission is creating affordable housing in downtown Ann Arbor. More information and details are to come.

Facial Recognition - CM Song: CM Song reported that the Ann Arbor Police Department has paused the deployment of the software company called Trulioo to review police camera footage using artificial intelligence. Further review and discussion will be held with the new Ann Arbor Police Chief. More information and details to come.

AAPD Update - L. Stambaugh: L. Stambaugh reported that the new Police Chief for the City of Ann Arbor is Andre Anderson.

Commissioners were invited to attend the swearing-in ceremony for the new Police Chief. L. Stambaugh discussed that the Independent Community Police Oversight Commission is planning to host another Public Forum. HRC Outreach Strategies - L. Stambaugh: L. Stambaugh shared that City Council passed a resolution denouncing rising hate and discrimination in Ann Arbor and calling for a lasting bilateral ceasefire in Gaza and Israel. The Ann Arbor City Council requests that the Ann Arbor Human Rights Commission engage with affected communities to let them know that they can file complaints with the HRC of violations of
