#### Elizabeth:

Most of the relevant correspondence is below. Whether we can get a cross-lot is dependent on the terms of the agreement with the city (which I have been waiting for a draft), the easement terms, the ultimate agreement by the neighbor and the permitting.

I had hoped all of these would be done by now, but as I informed you some weeks ago, I need the draft agreement from the city to present to the neighbor with the easement. You said you would get it to me.

On June 28th, I wrote to you regarding getting the documents that: "The sooner the better so we can determine whether we can actually get a written agreement from our neighbor to grant the easement and deal with the conditions. If we cannot, we will need to have the extension project completed this year and make sure your group is on track to do so."

You responded: As we've discussed, we will be able to let you know by July 15 if we're able to construct the sewer extension this year.

At the end of June, and at least twice in July I followed up to try to get a copy of the draft agreement. For example on July 1 you stated: "We're working on the draft agreement and will send that to you once complete."

More than two weeks later on July 18th, you wrote almost the same thing, but for the first time indicating that you have stopped work on our request to have sewer service to our home even though I know you are aware we do not have a crosslot connection, nor has one been permitted, and our neighbor has not granted us an easement in connection with any agreement with the city.

Could you please address these issues today?

- 1. Can we have the draft agreement today? We cannot move forward without it, and have waited too long for it already.
- 2. Whether the sewer project can be completed this year?
- 3. If not, why not, and what conclusions have been reached regarding that project?
- 4. What will non-completion this year mean for next year if there is no agreement on the cross-lot connection?



We NEVER told you we were pursuing the crosslot connection to the exclusion of the Geddes project, and everyone on this email list knows that. We do not even know whether we will get our neighbor's agreement to do a crosslot connection.

Until we know which project is actually feasible, we cannot pursue either one, and we have been waiting patiently for your promised delivery of news on July 15th whether or not the City will put in the connection this year. We need an answer to whether the city can build the project this year and would like a follow up meeting tomorrow.

#### Elizabeth,

We have not heard back from you regarding the message below from June 2nd.

In addition to Angela's comments and questions below, I'm sure you understand we would prefer not to wait 40 days to see if the sewer project is possible before obtaining everything needed to get immediate approval. Our tanks were pumped out, at a \$600 cost, just 5 weeks ago and are already backing up. Meanwhile, sewage continues to run into the back yard. I understand the desire by the city to lay new sewer, but the city has had 6 years to plan the project and determine whether it will even be able to serve our entire house, and it still has not happened. Delaying what could be an immediate connection for another 40 days will be expensive and smelly for us and seems much too late.

Would you please address the issues below, and please provide the schedule dates and deadlines you discussed. We would like to have permitting and applications complete right after July 15 so we can connect at that time, rather than waiting to start the process in July. It may be possible to confirm the project will not be completed or will not serve the whole house earlier and we would like to work with you on the dates that take place between now and then.

Hi Elizabeth,


As you and Rick have discussed, we will need service to our entire home (including the basement) without a lift pump in the Geddes project. We do have discharge from our basement, and our septic field has failed. It does us no good to have sewer to our first and second floors and septic for the basement. That puts us in a worse position than we are now. Will you be able to give us that information by July 15th also? Certainly, the City would prefer that we do a cross-lot connection if our entire home cannot be serviced without a pump.

It would also help to have an explanation as to why the cross-lot connection would only be allowed in the event the Geddes project cannot be completed this year. Everyone we have spoken to has indicated to us that the cross-lot connection is a better option for us from a feasibility perspective, so what has changed?

We need to know what the City means by when the lead "fails?" What is considered a failure? Does that mean that if we have any problems with the lead, that we will not be able to repair it, or does that mean that the lead has to be beyond repair before it is considered to have failed?

Finally, it would help to have an explanation about why we would need to pay the improvement charge in the cross-lot connection since the City will not be building the improvement.

As always, thank you for your help. If it makes more sense to have a meeting or call to discuss these questions, please let me know.

Hi Angela. I left you a voice message also. I met with Sue McCormick yesterday and we discussed a schedule, though it is really tight, that would have the sewer built in November. We also discussed an alternative to allow the cross lot connection in the event we cannot get it built this year. We will let you know by July 15 if we are on schedule to get it built this year.

If we are not, then we will offer the option of cross lot connection. This would require that you obtain an appropriate agreement with your neighbor. You will also be required to pay all the same applicable fees associated with a connection to the main (e.g., improvement charges, connection charges, tap fees). Another condition of the crosslot sewer would be that when the lead fails, you (or the future owners) would be then required to connect to the main in Geddes. Please let me know if you have any other questions. Thanks, Liz



#### Hello Liz,

I got a call from Tony Derezinski a little while ago letting me know that you would be calling either today or tomorrow to talk about some alternatives that could happen this year.
