#### C-1 Project Update - SRE Building/Environmental Assessment

*Mr.* Kulhanek gave updates on these two projects. There has been little change in the SRE building project as the contractor has not completed the punchlist items. The City has had discussions with the bonding company regarding the claims filed and the contractor's ability to complete the project. The Airport is still waiting to hear back from the FAA regarding the EA. Mr. Kulhanek recently sent an email to the FAA requesting a status update but has not yet received a response.

#### D-1 FAA Tower Report - C. Smith

#### D-4 FAASTeam Report - D. Schrader

Chris Gordon provided information on the June 4th pilot workshop presentation planned with the USDA. The workshop, organized in conjunction with A2GA2, will focus on wildlife hazard mitigation for pilots.

#### D-5 A2GA2 Report - C. Gordon

Chris Gordon reported on a number of items that the A2GA2 is working on. A2GA2 adopted the section of Lohr Road along the airport through the County's adopt a road program. The group held their first road clean-up day on 5/14/11. They are working with the local FBO's and flying clubs for the first annual International Learn to Fly Day which will be held on 5/21/11. They are participating with the Young Eagles program through the EAA to give local youth an exposure to aviation. They are also planning a fudge run to Mackinac Island to benefit the Mott Foundation and local hospitals.

#### Presentation - Pittsfield Township Master Plan

Paul Montagno, Pittsfield Township Planner, presented a draft of the 2010 Pittsfield Master Plan. His presentation focused on components of the plan which relate to the airport or areas surrounding the airport. Comments on the draft Master Plan are being solicited through June 20th and can be directed to Mr. Montagno. There were a number of comments and questions for Mr. Montagno by members of the Committee, summarized as follows: lack of reference to airport plans such as approach plans, 1979 agreement as amended regarding compatible land uses, and the airport layout plan; use of airport property, which is already off the tax rolls, as a transit center; airport property on the east side of State Road is not consistent with the rest of the airport property on the future land use map; the propsed use of the State/Ellsworth area is too dense and includes a residential component which is not compatible with an airport; draft does not seem to take Michigan Airport Zoning standards into account. The Committee asked that comments be submitted to the Township.

F-2 State Road Environmental Assessment - WCRC

The Washtenaw County Road Commission (WCRC) is preparing an Environmental Assessment (EA) for improvements to State Road from Ellsworth south to Michigan Avenue. They have sent a letter to the airport as part of an early coordination effort to identify key issues that must be addressed in their process. The Committee asked that the airport manager prepare a response and circulate for Committee comments prior to the June 30th deadline from the WCRC.
