Dear Tony and Jane,

This is in response to Assistant City Attorney Fales' email message sent to all Council members at 5:42 pm today and reproduced below.

- (1) I suspect that the AATA is an entity of convience for the City of Ann Arbor, which I understand has absolute control over the AATA.
- (2) The City of Ann Arbor will not control the proposed county-wide authority.
- (3) Ms. Fales' remarks do not address the question of how the City of Ann Arbor can be assured that the county-wide board will provide services in Ann Arbor that are consistent with the requirements of City Charter Section 18-3.

Also, I just looked at part of the text of the Public Transportation Authority Act (1986 PA 196; MCL 124.451. et seq. All sections of the act are listed at http://www.legislature.mi.gov/(S(ha3bal45urwt4n45wp3p1q45))/mileg.aspx?page=getObject&objectName= mcl-Act-196-of-1986

The statute at MCL 124.456 describes the contents of the articles of incorporation. You can read that section at Section 124.456. There is nothing in the law requiring the City of Ann Arbor to commit the proceeds of a public transportation millage at this point in time.

Also, I refer you to the provision of the statute, at MCL 124.479, which addresses the question of the duration of any financial obligation to the public transportation authority. You can read that section at Section 124.479 It explicitly states that a vote of the electorate is required if the duration of a financial obligation is more than five years.

Commitment of the City's 2.5 mills public transportation property tax to the proposed county-wide agency at this point in time is extraordinarily careless.

CM Lumm has inquired if there any state laws or regulations requiring AA voter approval to transfer assets or millages from AATA/City AA to the new authority?

The voter approved millage is for the purpose of providing funds for operating and equipping a public transportation system for the City. The City has the statutory authority to operate a public transportation system or to contract for the operation of a public transportation system. A separate vote on the assignment is not required. The current assignment of millage funds raised under the provision of Section 8.19 of the City Charter to AATA is contractual. If approved the terms of the 4-Party Agreement contractually obligate the City to transfer those same millage funds to the NEW TA.

ANN ARBOR POLICE DEPARTMENT LAUNCHES ONLINE CITIZEN INCIDENT REPORTING SYSTEM

ANN ARBOR, Mich., January 9, 2012 — In January, the Ann Arbor Police Department launched an online citiz reporting system that enables citizens to report minor crimes online at www.a2gov.org/police. This system mean that citizens no longer have to drive downtown to file a report in person, and the police department can focus departmental resources on more urgent matters. These reports typically do not require a police interview or follo up investigation but they are often needed for insurance claims or other matters. The online reporting system is easy to use and available 24 hour a day. This is one more way that the Ann Arbor Police Department is working find creative ways to improve the services that they provide to the community. The following types of reports ca be made on line:

- Harassing phone calls- You are receiving numerous "hang-up" phone calls by an unknown caller
- Theft-Your property was taken by an unknown suspect. There are no witnesses to the incident.
- Vandalism- Your property was damaged by an unknown suspect. There are no witnesses to the incident
- Identify theft- An unknown suspect uses your personal information to obtain credit or make purchases on your credit card out of city or state.
- Lost or damage property-
- Private property traffic crashes- A vehicle is left parked, unattended and you return to find that the vehicle has been struck.

Please note that new hours are now in effect for the Ann Arbor Police Services Unit records section, detective bureau administration office, property unit and police payroll office. These units will be closed to the public on Fridays. The offices will be open to the public Mondays—Thursdays from 9 a.m. to 12 noon and 1 p.m. to 4 p.m., with the exception of city government holidays.


