Mayor Hieftje introduced David Essau, Architect for Cornerstone Design and representative for the 415 W. Washington Committee, who addressed Council regarding the 415 W. Washington Progress Report. Mr. Essau gave a slide presentation, which explained the committee's efforts to explore the possibility and feasibility of establishing an arts space at 415 W. Washington. The following surveys are needed in the first steps: Hazardous materials assessment \$5,200.00, Hazardous materials assessment, phase 2/3 environmental assessments, \$20,000.00, Topographic and boundary survey \$6,200.00, Structural condition survey \$3,000.00 to \$5,000.00, and Architectural/structural as-built survey \$8,000.00. After the surveys are completed, the following would be explored and developed: Hazardous materials abatement plan, Structural feasibility analysis, Programming & design feasibility, Site & environmental feasibility analysis, Cost analysis, Partnerships and Fundraising. # 1. Thomas Partridge - Advance the cause of human rights and disability rights in America. Re-elect Present Obama. Provide affordable, accessible county-wide public transportation. (I-4, I-5, I-6, I-7)

Thomas Partridge, Ann Arbor resident, addressed Council regarding advancing the cause of human rights and disability rights in America, re-electing President Obama and providing affordable, accessible county-wide public transportation.

# 2. Kermit Schlansker - Space Heating

Kermit Schlansker, 2960 Marshall, addressed Council regarding space heating. He said that every furnace now being sold in the US is obsolete. Furnaces are devices that only create heat. He added that heat is a bi-product of making energy and those furnaces could manufacture electricity while making heat. Electricity and heat combined is otherwise known as pro-generation. All heating devices using combustible fuels should be engines, not furnaces. He said that large amounts of energy needed to heat buildings would produce a surplus of electricity in the winter. He concluded by stating that co-generation, heat pumping and car manufacturing will not only keep us warm in the future, but could also make millions of new jobs.

# 3. Nanci Gerler - Stop Smart Meters

Nanci Gerler, 1613 Dicken Dr., said that there has been a lot of conversation around the smart meter installations in Michigan. Five other communities have issued resolutions and bans on the installation due to health concerns. She called on the Mayor and Council to put an immediate halt to installation and a ban on smart meters in Ann Arbor.

#### 4. Henry Herskovitz - Democracy and Council Elections

Henry Herskovitz, 404 Mark Hannah, said that Ann Arbor.com reported on April 23, 2012, that the director of the Interfaith Council for Peace and Justice entered the 5th Ward race for a seat on City Council. That came as a shock to former members of the Middle East Task Force, since under the leadership of this director, the taskforce was disbanded by ICPJ's board of directors in violation of their own core value, not using power to dominate. Voters in the 5th Ward deserve to have representation on City Council by someone who embraces democratic ideas, not someone who would abandon due process in exchange for political expediency, he said.

# 5. Darren Schmidt - Smart Meters

Dr. Darren Schmidt, 1117 Wines Dr., addressed Council regarding smart meters. He spoke in support of halting smart meter installation and looking for a viable alternative to them. He said he started seeing patients approximately four years ago with symptoms that were difficult to diagnose and treat using normal tools. He discovered that they were electro-magnetically hypersensitive to electro-magnetic fields and radio frequencies. He attended two seminars last year given by other doctors who found the same problems with their patients related to smart meters.

# 6. David Foster - Flooding

David Foster, 2240 Mershon, addressed Council regarding the recent flooding in Ann Arbor. He said that his family experienced severe water damage due to excessive flooding in his home during the storms in March 2012. Rain water filled the streets to a level that rendered them impassible by vehicles. Water build-up created a river effect in many areas of the neighborhood. The water created ponds in his neighbor's yards and storm drains were overwhelmed. Rain water around his property entered his basement. Mr. Foster requested that City Council acknowledge that there is a real problem that exists with the City's stormwater drain system and asked that they study this issue and take action to ensure that this would not happen in the future.

#### COMMUNICATIONS FROM COUNCIL

#### **COUNCILMEMBER HIGGINS**

Councilmember Higgins said that she introduced Mr. Foster and Ms. Fisher to Interim Public Services Area Administrator Craig Hupy prior to tonight's meeting and Mr. Hupy will work with residents in the Lansdowne neighborhood regarding flooding issues.

#### COUNCILMEMBER SMITH

Councilmember Smith said that the DDA is hosting a "Great Places Speaker Series" on the Connecting Williams Street Project on May 17, 2012 at 5:00 p.m. at Conor O'Neal's. The topic will focus on economic development in the area. The prior two events in the series have been videotaped if anyone is interested in watching them. Video of the series is available at a2dda.org.

#### COUNCILMEMBER ANGLIN

Councilmember Anglin mentioned that Madison from Seventh to S. Main should be considered as the Capital Improvements Plan is reviewed. He noted that part of the excessive deterioration of some streets may be due to bus traffic.

#### COUNCILMEMBER LUMM

Councilmember Lumm said that the Partnerships Committee and the DDA are looking at a Brownfield Policy, which would be a policy to award TIFF Funds for a period of time for blighted and distressed properties. The policy being formulated has been to the Partnerships Committee a few times, the DDA, and is now going back to the Partnerships Committee on May 17, 2012. She welcomed any feedback that Council may have on the policy.

# MAYOR HIEFTJE

Mayor Hieftje requested more information regarding the Madison Street resurfacing schedule. City Engineer Homayoon Pirooz said that Madison Street from Seventh to Main is in poor condition and has to be rebuilt basically from scratch. That will require summer work. Seventh Street is being resurfaced this year at the opposite end and the detour for Seventh will include Madison, so it is a coordination problem. Madison is on the list for 2013, Mr. Pirooz stated. After further discussion, Council asked staff to provide information on the previous Madison Street resurfacing project.
