Meeting Minutes

CALL TO ORDER

Chairman Ezekiel called the meeting to order at 4:35 p.m. in the Guy C. Larcom, Jr. Building, 2nd Floor Council Chambers, 301 E. Huron St.

A motion was made by Commissioner Rubin, seconded by Commissioner Riseng, that the Agenda be approved as presented. On a voice vote, the Chair declared the motion carried.

SPECIAL PRESENTATIONS

1. Richard Andres – Washtenaw County Food Hub

Richard Andres addressed the commission regarding the Washtenaw County Food Hub. He said that creating a belt of preserved land is key in bringing food in to town, and taking compost out. It also helps the local economy. He said that his property is approximately 20 miles outside of town, still within Washtenaw County. He said that he would like to create a station on his property with enhanced distribution for their own CSA as well as other farmers who may want to participate. The site has historically served as a place to support farmers, providing bins for fertilizer, grain, mixing various products, etc. They would like to repurpose the site and use it for a destination for people who want to participate in CSA distributions and local food. The idea is to set up large coolers, freezers for storing over winter, an area to wash and pack vegetables. There would also be a warm area for people to come in the winter to pick up shares. It would be open more than one day a week during the winter. It would be an enhanced site that would support farmers and the community. It would support farmers with loading docks, bays for storing fertilizer and buying in bulk, and creating a better network of distribution and retail sales. Mr. Andres then answered questions of the commission.

NEW FRPP GRANT APPLICATIONS

Ms. Trocchio announced that the Conservation Fund has submitted four properties for FRPP Grants, totaling 519 acres, requesting \$1,037,198.00. State wide, there was \$2.3 million available. Ingham and Kent Counties have submitted FRPP Grant applications as well.

CLOSING OF VARIOUS PROPERTIES

Ms. Trocchio reported that they are expecting to close on another four properties, totaling another 300 acres within the next couple of months. One of the properties is in Superior Township, with Southeast Land Conservancy and Washtenaw County; another in Ann Arbor Township, with Washtenaw County and Ann Arbor Township; another in Ann Arbor Township with FRPP and the Township.
