The funds that the Council authorized for the matching grant -- on May 21 -- were up to \$307K. The University and the City remain in negotiation about the University's contribution toward that.

Because the Braun Nature Reserve is a natural area, not a green-grassy park, maintenance will be minimally expensive. It will be maintained at the same level as the Huron Park Nature Area, and on the same schedule.

efforts were funded by the Major Street, Alternative Transportation and Economic Development Funds in the FY10 through FY12 budgets, along with University of Michigan funding, all as previously approved by City Council, with additional funds available, if needed, from the approved FY13 budget --- What is the amount of the additional funds?

This resolution, if approved, would <u>accept the donation of Braun Park</u>, which was originally dedicated "to the use of the public" as part of the plat of Washtenaw Hills Estates. The City expects the property to become part of the parks system, and to remain a natural area in conjunction with the Huron Parkway Nature Area. How is the park system able to afford to maintain this new park?
