#### 1. MLCC Approval Changes

The committee discussed some of the recent changes at the State regarding the approval of new and transferred licenses. City Clerk's Office staff outlined some of the difficulties they were encountering with the current process at the local level, including the collection of fees and the local inspections, now that the MLCC does not require local approval.

It was moved by Councilmember Lumm, seconded by Councilmember Anglin, that the City Clerk would no longer collect fees for license transfers of packaged sales (SDD and SDM licenses) or for Outdoor Service permits for on-premise licenses. Any applications that were currently pending with the City Clerk's Office where inspections had not yet been performed would be refunded to the applicants. On a voice vote, the Chair declared the motion carried.
