1. Hugh Sonk - Resolution to Review D1/D2 Zoning and Establish Moratorium (DC-1)

Hugh Sonk, 505 E. Huron St., spoke in support of the proposed moratorium. He urged Council to study the Design Guidelines during the moratorium and to take the time to study the issue before approving new development.

2. Susan Morrison - Resolution to Review D1/D2 Zoning and Establish Moratorium (DC-1)

Susan Morrison, 124 Brooks, attorney representing Eileen and Norman Tyler, residents of the Division Street Historic District, spoke in support of the moratorium. Ms. Morrison stated she previously sent Council a communication outlining the legal basis for approving a moratorium.

3. Peter Nagourney - Resolution to Review D1/D2 Zoning and Establish Moratorium (DC-1)

Peter Nagourney, 914 Lincoln, spoke in support of the moratorium. He said the City has an obligation to its citizens and to not re-examine the Design Guidelines would be an act of bad faith.

4. Norman Hyman - Resolution to Review D1/D2 Zoning and Establish Moratorium (DC-1)

Norman Hyman, 300 E. Long Lake, Bloomfield, MI, said that the courts will not object to a reasonable moratorium for a reasonable period of time.

5. Patrick Lennon - Resolution to Review D1/D2 Zoning and Establish Moratorium (DC-1)

Patrick Lennon, 350 E. Michigan Ave., Kalamazoo, MI, spoke in opposition to the proposed moratorium and urged Council to defeat the resolution. He stated that the moratorium as proposed is unfair, improper and could be subject to legal challenge. *Mr. Lennon, a representative for the 413 E. Huron Street project, stated the proposed moratorium goes to lengths to exclude other projects while specifically including his project.*

6. Carl Hueter - Resolution to Review D1/D2 Zoning and Establish Moratorium (DC-1)

Carl Hueter, 817 S. Seventh, spoke in opposition to the proposed moratorium. He stated that imposing a moratorium on a project that is so far through the development process is frightening and sends a really frightening message to other property owners and developers.

7. Tom Stulberg - Resolution to Review D1/D2 Zoning and Establish Moratorium (DC-1)

Tom Stulberg, 1202 Traver St., thanked Council and the public who have worked on the entire downtown zoning process. He spoke in support of the moratorium and urged Council to take the time to study the issue again.

8. Susan Friedlaender - Resolution to Review D1/D2 Zoning and Establish Moratorium (DC-1)

Susan Friedlaender, 33493 W. 14 Mile Rd., Farmington Hills, MI, representing the petitioners of the 413 E. Huron St. project, spoke in opposition to the proposed moratorium. She stated a moratorium on the 413 E. Huron St. project is in "bad faith," and the courts have shown that they will find a moratorium invalid.

9. Ray Detter - Resolution to Review D1/D2 Zoning and Establish Moratorium (DC-1)

Ray Detter, 120 N. Division, representing the Downtown Area Citizens Advisory Council, spoke in support of the proposed moratorium as presented. Mr. Detter also spoke in support of re-establishing the Design Guidelines Taskforce.

COUNCILMEMBER BRIERE

Councilmember Briere said that the Public Art Taskforce's proposed Public Art Ordinance amendments are still being reviewed by the City Attorney's Office. The taskforce will need to wait until the first meeting in April to present the changes to Council.

COUNCILMEMBER KUNSELMAN

Councilmember Kunselman said that a Taxicab Board meeting was held last week. There was a guest speaker from the Great Lakes Limousine Organization who was very informative. As a result of some of the activities in the City regarding taxicabs and limos, HB4343 has been introduced in the Legislature. Councilmember Kunselman stated he hoped this future legislation would provide some of the language the City is looking for to close some current loopholes.

COUNCILMEMBER LUMM

Councilmember Lumm thanked City Administrator Steve Powers and the Field Operations Service Unit for being proactive in terms of their assistance with debris clean-up from last week's storm. She said that citizens are very appreciative of the City's efforts.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR

WINTER STORM UPDATE

Public Services Area Administrator Craig Hupy updated Council and the public on the clean-up efforts from last week's storm. Mr. Hupy said that the weight of the snow made it harder to move around. He said that crews are driving down streets cleaning up limbs that were broken, but had not actually fallen to the ground. Beginning Wednesday, March 6, 2013, crews would drive through City streets with chippers cleaning up any debris that has been placed on lawn extensions for removal. He added that the City prefers that residents bring branches out intact, as it is easier for them to handle with the chippers; there is no need to cut and bundle the branches. Mr. Hupy said that the Burns Park area would be taken care of first, as they were the hardest hit from the storm. It is expected to take a full two weeks to have all of the debris cleaned up and a second pass through the City would occur the week of March 20, 2013.

ARGO CASCADES

City Administrator Steve Powers announced that Argo Cascades has been recognized by the Michigan Recreation and Parks Association for Park Design of the Year. The Cascades were also recently designated a frontline park by the City Parks Alliance, which is a national organization that recognizes inspired examples of urban park excellence.

		Sandra Sorini, 201 S. Division St., attorney representing Galileo Associates, owners of Zaragon Place which is a student apartment building located at 619 E. University, said that the Zaragon owners are not opposed to the project in concept. They expressed concern with the health, safety and welfare of their student residents because the developer is proposing to locate the western wall right at the developer's property line and would essentially use the backyard of Zaragon Place for construction. She objected to this use.
		Jim Caesar, Vice President of Design Build, addressed safety concerns that had been previously raised. He said that they have a safety track record that is leading the industry. They take safety as a number one priority. He added that they have taken great strides to eliminate the need to swing anything, bring in equipment or have air rights encroachments. These efforts have been made to avoid any conflicts with neighboring Zaragon East.
		Scott Munzel, 603 W. Huron St., representing Opus Development Corporation, said that the site plan meets all of the City rules and related goals. It is consistent with the master plan that has been adopted, specifically the downtown plan, which encourages the highest concentration of activity in this area.
		Alan Haber, Ann Arbor resident, expressed concern with the proposed site plan and the relationship that it has with the proposed moratorium on tonight's agenda.
