1. Thomas Partridge - A plea, a prayer to advance the cause of human rights. Provide access for public participation in all Ann Arbor city meetings. Fund affordable housing and transportation. Recall irresponsible public officials.

Thomas Partridge, Ann Arbor resident, addressed Council regarding a prayer to advance the cause of human rights, providing access for public participation in all Ann Arbor City meetings, fund affordable housing and transportation and recalling irresponsible public officials.

2. Kermit Schlansker - New Construction

Kermit Schlansker, 2960 Marshall, addressed the recent debate over the construction of more high-rise apartment buildings on Huron Street. He stated that sustainability and alternative energy should be a part of this discussion. Mr. Schlansker said that the City can make a big step toward sustainability by specifying that all new buildings must use a partially renewable heating system. This could take the form of solar panels on the roof, a solar boiling, heating and cooling system, a co-generation heating system, an engine driven heat pump, heating and cooling system or a co-manufacturing heating system. These systems have the capability of saving large amounts of energy throughout the US and are essential to our children's future, he said.

3. Stewart Gordon - Update on Ice-Rink

Stewart Gordon, 192 Barton Shores, updated Council on the downtown ice-rink proposal. He passed out a report of a phone interview he conducted with Jennifer Hesse who runs a rink in the Chicago area. A copy of the report is on file in the City Clerk's Office.

COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER PETERSEN

Councilmember Petersen announced that she attended the private opening of the Big Salad on Plymouth Road. The Big Salad offers custom made salads, healthy and hearty soups and sandwiches. They are a great addition to Plymouth Road, offering healthy food choices. The public grand opening is scheduled for April 3, 2013.

Councilmember Petersen said that two weeks ago she made an announcement that she was going to be bringing forward a resolution tonight to form a DDA Taskforce with a specific assignment of conducting a strategic assessment of the priorities for economic development between the DDA and the City. The scope has been changed a bit and Ms. Petersen said she hopes to have the resolution ready in two weeks. The focus would be economic development, not just the DDA specifically, but focusing on the task of economic development and aligning the priorities of the DDA and the City, as well as Spark. Councilmember Peterson is working with the City Attorney's Office on the final draft to be ready in two weeks.

COUNCILMEMBER KAILASAPATHY

Councilmember Kailasapathy provided an update on the Audit Committee and questions that she raised at the last meeting regarding the audit. She said the committee did get a response from the DDA auditors. The auditors said that they did not review the TIF funds for Chapter 7 compliance. Councilmember Kailasapathy said this is troubling for her because the DDA's own 2003 renewal plan specifically stated that the TIF account has to be tested for compliance as per Section 15.3 of the State of Michigan Downtown Development Authority Act. The auditor's own report on internal controls and compliance states they have performed tests of compliance, but when asked whether the TIF Fund was tested for Chapter 7 compliance, they said no. She said that both the CFO of the DDA and the City's CFO need to address this issue.

COUNCILMEMBER TEALL

Councilmember Teall responded to comments made that as chair of the Audit Committee, she was unwilling to call a meeting. She stated the Audit Committee has always been willing to meet with the DDA, but she was waiting for DDA staff to be available to discuss these issues. Councilmember Teall said now that Joe Morehouse is back to work, they will be meeting as a committee with the DDA on April 2, 2013. She said the DDA has acknowledged shortcomings in the audit and they are working to resolve those issues.

Councilmember Teall said she attended the public meeting for the artists who are applying to create the Stadium Bridges public art piece. She thanked the taskforce for doing a great job on this project and to all of the artists who have proposed outstanding work.

Councilmember Teall reminded Council and the public that FestiFools is scheduled for April 7, 2013 from 4-6 p.m. on Main Street, as well as the Fool Moon on Friday evening.

COUNCILMEMBER ANGLIN

Councilmember Anglin urged the public to watch the March 21 meeting of the Park Advisory Commission (PAC). There were two presentations given by staff. The first was presented by Doug Kelly, Leslie Golf Course Manager. The second presentation was made by Cheryl Saam, a canoe livery staff member who was played an integral role in the rerouting of the river to create the Cascades. He said that both staff members gave great presentations at the PAC meeting.

COUNCILMEMBER WARPEHOSKI

Councilmember Warpehoski said that while at his neighborhood park he noticed some illegal dumping. He contacted Parks staff who responded immediately to the issue. He thanked Parks and Recreation Manager Colin Smith, Park Planner Amy Kuras and others who were very responsive.

Councilmember Warpehoski said that in thinking about dumping illegally or otherwise, the one reoccurring theme that everyone seems to complain about is the dumping of unwanted advertising circulars and the unsolicited delivery of these newspapers and circulars to neighborhoods. Councilmember Warpehoski stated these unwanted deliveries create litter, environmental waste, blight and the piling up in driveways sends a message to criminals that the residents may be away. Councilmember Warpehoski requested members of the public contact him regarding their experiences and provide any feedback or complaints.

COUNCILMEMBER BRIERE

Councilmember Briere updated Council on the taskforce that is looking at the North Main area. It has named itself the North Main Huron Valley Huron River Vision Taskforce. The group has been meeting every three weeks as a whole and is broken into four subcommittees that have met at least once or twice a month or more in order to come up with recommendations. The draft recommendations were presented at their meeting last Wednesday. Those recommendations will be complied, organized and looked at again before April 17. A draft reported is expected to be completed before the beginning of May and the Taskforce expects to hold public hearings on the report on May 22 and again in June. The full report would then come before Council by the end of July.

COUNCILMEMBER KUNSELMAN

Councilmember Kunselman said that a few councilmembers attended the Urban Core Transit group meeting last Thursday. It was an interesting discussion with other elected officials from other jurisdictions regarding the AATA services. He said that it was a robust discussion about governance and financing, how they can come to and improve a number of options, as well as sustain, improve or expand the Ann Arbor Transportation Authority's ability to provide services to the greater urban area. He added that another meeting is being scheduled soon.

MAYOR HIEFTJE

Mayor Hieftje said that he, Councilmembers Kunselman, Warpehoski, Petersen and Briere attended that Urban Core Transit meeting as well. He said that the next meeting is scheduled for April 22, 2013.
