#### 1. Leslie Stambaugh - New Video Privacy Ordinance (C-1)

Leslie Stambaugh, 1940 Ridge Ave., read a proclamation from the Ann Arbor Human Rights Commission in support of the proposed Video Privacy Ordinance.

#### 2. Norman Tyler - FY2014-2015 Budget

Norman Tyler, 126 N. Division St., addressed Council regarding the proposed City budget. He encouraged Council as they consider the City's budget, to allocate resources necessary for adequate staff review of major construction projects and proper zoning review.

#### 3. William Leaf - New Video Privacy Ordinance (C-1)

*William Leaf, 1825 Hill St., spoke in support of the proposed Video Privacy Ordinance.* 

# 4. Tom Partridge - End Ann Arbor housing discrimination. Reform city zoning and planning ordinances and policies to assure non-discrimination in housing by providing affordable housing throughout the city. Call for the resignation of irresponsible public officials including Mayor Hieftje and Governor Snyder. (B-1)

Tom Partridge, Ann Arbor resident, addressed Council regarding ending Ann Arbor housing discrimination and reforming the City's planning and zoning ordinances and policies to assure non-discrimination in housing.

#### 5. Widdicombe Schmidt - Weather Change from Large Building

Widdicombe Schmidt, 511 W. Ann St., addressed Council regarding building large structures in the City. He urged Council to consider how the construction of large buildings affects the weather in the downtown, including the increased effects of wind.

#### 6. Christine Crockett - Heritage and Historic District

*Christine Crockett, 506 E. Kingsley, addressed Council regarding historic districts and the importance of preserving the City's heritage.* 

#### 7. Ellen Ramsburgh - Zoning within the DDA Boundary

*Ellen Ramsburgh, 1503 Cambridge Rd., addressed Council regarding the zoning within the DDA boundary, including the D1 and D2 zoning designations.* 

#### 8. Jeffrey Hayner - General Comments

Jeffrey Hayner, 1807 Pontiac Trail, addressed Council regarding the budget. He spoke about the need to allocate some of the street and sidewalk millage repair funds to fix the sidewalks near Bandemer Park.

#### 9. Caleb Poirier - General Comments

Caleb Poirier, 1324 White St., delayed his comments until the public hearing for Ordinance 13-05.

#### 10. Ilene Tyler - FY2014-2015 Budget

*llene Tyler, 126 N. Division St., addressed Council regarding the proposed City budget. She stated there is not currently enough staffing to address planning and zoning issues. She expressed concern with the current noise ordinance as it relates to construction projects.*

Steve Sonntag, 2310 Pauline Blvd., addressed Council regarding the fluoridation of water and the City's water supply. He urged Council and the public to look into the dangers associated with the fluoridation of water.

#### COMMUNICATIONS FROM COUNCIL

#### COUNCILMEMBER KUNSELMAN

Councilmember Kunselman said that the far east side of Ward 3 is one of the largest geographic areas within the city with low to moderate income families. There is a shopping district that fronts Saint Aubin Ave., which is a city-owned public right-of-way. That right-of-way has been neglected by the City for at least the last decade. The business owners of that area have not been able to get assistance with restoration of Saint Aubin. He asked staff if that restoration would be able to take place and was told that in order to do so, those businesses would have to set up a special assessment district and pay for it themselves. The City has had a change of opinion and he shared with Council the following statement from an email he received regarding the issue:

Project Management staff indicates that based on the pavement condition rating for this section of roadway, this section will be under consideration for inclusion in the 2014 street resurfacing program. Under consideration doesn't mean that it would be included in the program, but the section would be evaluated and priority given for other street conditions.

Councilmember Kunselman said that this is very exciting and he would be looking forward to having his colleagues' support for in including the Saint Aubin Avenue resurfacing in the 2014 street resurfacing program, so that those businesses that service the low to moderate income families in that area have the same infrastructure improvements that have been seen elsewhere in the City.

Councilmember Kunselman announced that he would be requesting to postpone B-2 (Chapter 7 - Downtown Development Authority Ordinance Amendments) and also requesting the Mayor to keep the public hearing open as well.

#### COUNCILMEMBER HIGGINS

Councilmember Higgins said that as Chair of the Budget Committee, she asked a member of the Committee to collect all of Council's proposed amendments for the upcoming budget. This allows for a single collection point and one point of contact for staff for any proposed budget amendments Council may have. Councilmember Higgins said that Councilmember Lumm will be this year's collection point (councilmember) for all budget amendments and all amendments should be forwarded to her. Amendments should be sent by 5 p.m. on Tuesday, May 14, 2013, so that the amendment document could be sent to Council by Thursday, May 16, 2013. Councilmember Higgins reminded her colleagues that early submission of possible amendments to Finance allows for staff to have time to analyze the budget impact of the amendments. Councilmembers could submit a proposed amendment for review and still later decide not to make the amendment during the budget approval.

Councilmember Higgins said that the Admin Committee has requested City Administrator Powers schedule a workshop with the Michigan Municipal League (MML) to speak with Council regarding attorney/client privilege information.

*City Administrator Steve Powers said that April 29, 2013 has been scheduled for the MML to speak with Council.* 

#### COUNCILMEMBER WARPEHOSKI

Councilmember Warpehoski announced that any member of the public who signs up for the Commuter Challenge during the month of May will receive a free cookie from The Lunch Room, a new restaurant located in Kerrytown.

Councilmember Warpehoski stated he and Councilmember Anglin are hosting a townhall meeting in the Fifth Ward to discuss the proposed changes to the Sign Ordinance. The townhall will be held at Downtown Home and Garden on April 29 starting at 7 p.m.

#### COUNCILMEMBER BRIERE

Councilmember Briere said the Public Art Task Force would be bringing an ordinance amendment to Council at the first meeting in May. The Task Force has one more meeting scheduled and all proposed ordinance changes would be proofed by the members and then move forward in ordinance form to the Council for final review and approval.

Councilmembers Briere and Kailasapathy have been meeting with City staff and expect to bring an ordinance change that governs Chapter 12; dealing with infrastructure improvements to vacant lots. This change should significantly address some of the issues councilmembers have identified within the existing ordinance. The changes are being made to find an equitable and coherent way to assess new properties, including appropriate charges for sanitary and water service. This ordinance is expected to be ready for the May 6, 2013 Council meeting.

#### COUNCILMEMBER ANGLIN

Councilmember Anglin said that he was pleased to see the Superintendent of the Ann Arbor Public Schools at tonight's meeting. He thanked the City Administrator for starting the dialog with the schools.

#### COUNCILMEMBER TAYLOR

Councilmember Taylor announced that members are needed to serve on Local Development Financing Authority LDFA (3 seats will expire on June 30, 2013). The Greenbelt Advisory Commission GAC also has three terms expiring on June 30, 2013. GAC needs a farmer, a representative from an environmental organization and an at-large member for its commission. Contact the City Mayor's Office for an application for either board.

#### COMMUNICATIONS FROM THE CITY ADMINISTRATOR

#### NORTH MAIN DEMOLITION

City Administrator Steven Powers said that staff would be proceeding with demolition of the six structures on North Main. Previous Council action has established the funding of the Dangerous Building Fund and has established the process for staff to proceed. The demolition and site restoration is scheduled to take nine weeks for completion.
