COMMUNICATIONS FROM THE CITY ADMINISTRATOR

City Administrator Steve Powers said that there has been considerable interest in the condition of public roads across the State, due to the extreme number of potholes and the overall condition of the roads coming out of this harsh winter. The City has received 283 requests for pothole repair over the past two months, he said. The City has gone through 251 tons of cold patch and staff continue to respond daily to approximately eight major roads. Field Operations has a goal of addressing each pothole complaint within 24 hours.

		Police Chief John Seto updated Council on the overtime for dedicated extra traffic enforcement. The internal name given to the project is "26 Weeks of Safer Streets." Chief Seto stated the first officers were deployed as part of this assignment on January 9, 2014. Two officers per week have been dedicated to extra traffic enforcement efforts for either four or eight hour shifts each day and a total of 450 hours of overtime have already been scheduled. 80% of the efforts have been focused on pedestrian safety related concerns, including crosswalks and failing to yield. Chief Seto provided Council with a copy of an educational "ticket" that is handed out to drivers as a warning. Chief Seto stated the brochure has been effective because it grabs your attention as it looks like an actual traffic citation.	
		Chief Seto stated the AAPD Traffic Complaint Questionnaire also went live on the City's website on January 13. Since its implementation, 47 separate questionnaires have been completed and submitted. These questionnaires have been used to help identify targeted areas for enforcement.

1. Karen Kerry - Grant Application for Universal Access Playground at Gallup Park (CA-5)

Karen Kerry, 3031 Cedarbrook Rd., president elect of the Ann Arbor Rotary Club of Ann Arbor, urged Council to support the grant to help fund the universal access playground in Gallup Park. The playground is all inclusive, regardless of age or ability. Ms. Kerry said that the Rotary Club of Ann Arbor is committed to raising at least \$250,000.00 to support this project.

2. Odile Hugonot-Haber - Resolution Designating an Urban Public Park Location on the Library Lot Site (DC-6)

Odile Hugonot-Haber, 531 Third St., spoke in support of the proposed Resolution Designating an Urban Public Park Location on the Library Lot Site.

3. Julie Grand - Resolution Designating an Urban Public Park Location on the Library Lot Site (DC-6)

Julie Grand, 1604 Brooklyn Ave., addressed Council regarding the proposed Resolution Designating an Urban Public Park Location on the Library Lot Site. Ms. Grand stated she had some concerns with Items #4 and #8. These items in particular are asking the Parks Advisory Commission to act against their own recommendations, which were approved by City Council. She stated this resolution would place an undue financial burden on the Parks Department.

4. Ingrid Ault - Resolution Designating an Urban Public Park Location on the Library Lot Site (DC-6)

Ingrid Ault, 2531 Meade Ct., Chair of the Parks Advisory Commission, addressed Council regarding the proposed Resolution Designating an Urban Public Park Location on the Library Lot Site. She asked Council to consider postponing this resolution until all stakeholders could be included in the process.

5. Douglas Kelbaugh - Resolution Designating an Urban Public Park Location on the Library Lot Site (DC-6)

Douglas Kelbaugh, 223 E. Ann St., Unit 3, spoke about the proposed Resolution Designating an Urban Public Park Location on the Library Lot Site. He stated the downtown needs a real civic gathering place, but expressed concerns with the current proposal. Mr. Kelbaugh stated that a building besides the Earthen Jar would need to be oriented to face a public plaza and create interest and activity.

6. Margaret Parker - Resolution to Return Uncommitted Public Art Funds to Originating Sources (DC-3)

Margaret Parker, 2972 Parkridge, addressed Council regarding the proposed Resolution to Return Uncommitted Public Art Funds to Originating Sources. She said that the City needs to find an appropriate and sustainable way to continue an ongoing Public Art program, including the continued funding of an Art Administrator. She urged Council to leave the current funds in place to continue the program until another solution is found.

7. Alan Haber - Resolution Designating an Urban Public Park Location on the Library Lot Site (DC-6)

Alan Haber, 531 Third St., spoke in support of the proposed Resolution Designating an Urban Public Park Location on the Library Lot Site. Mr. Haber urged Council to listen to the people. He stated a downtown public space is wanted.
