You're welcome, Jane. I've had up to nine deer in my yard for weeks during the past winter. (I live two doors from Sally). Rutgers University has a website that lists plants that are resistant to deer, beginning with the most resistant to the least resistant. If people would start replacing their decimated shrubs and perennials with these, the deer wouldn't be such a problem. I also use a spray called Liquid Fence that smells horrible when it is applied but dries without odor and works well. There's also a granular form. This helps with a problem called "buck rub" in which the bark is removed by the deer's antlers or by chewing it. I doubt if the DNR can provide much assistance in culling the deer because its funds have been cut by the state like so many other agencies.

After you watch the program, you'll see why reducing the number of deer is a losing proposition. And, after all, they were here before us. You'll learn from the program that evolution dates the species back 23,000 years (I think that's what was reported. I saw the program on PBS when it was first broadcast.) or even further back in some parts of the world. My cousin who lives in the Upper Peninsula is a retired fish biologist who attended U-M School of Natural Resources. He said they had discussions 30 years ago about how to prevent the widespread growth of the deer population. There were no answers even then.

I have given this matter much thought. I have also spoken to the best and most experienced hunter I know: Mike Kreuzel. He's one of the owners of Stadium Hardware and we've been friends for 30 years. I have eaten much of his meat over the years. My grandfather was Indian and even when he lived with Europeans, he still went to the mountains and hunted game for my grandmother to cook. So I am not against killing deer or other game.

Mike says there are many ways to get rid of deer, but the two most humane ones are not feasible in a city. Yes, a very experienced hunter, with gun or bow, could shoot deer in the city, but probably would not. Even though they would hit the deer, there is always the possibility of the bullet going through the deer, hitting something that causes it to change trajectory, and then hitting something else. I'm a citizen volunteer for the A2 Police and would ask one of their sharpshooters how they deal with this problem, but I have only just been alerted to this activity on the issue in the past two days, so haven't had the time. My best guess is that they would tell me it's a risk worth taking if lives are at stake. Lives are not immediately at stake if there are deer in your yard. You hosta is at stake, though.

The other way is to snare the deer. It is a quick kill – it breaks their neck – but it would snare anything, including your golden retriever. You'd basically have to sit and watch the trap whenever it was set. Not feasible, or at least a very slow method.

I have read several places where game specialists are quoted who say that birth control is simply not feasible. Birth control doesn't always work. If you could shoot it into them in a dart, how would you mark them so that no one else shot it into them? And where could you shoot them safely – back to the gun question.

Deer fencing works. No one is going to try to fence in the city. Not a real option.

There are many other cities that have had this problem. It would be good to learn if any of them have found effective solutions.

And then there is the problem of the people who don't understand hunting, the need for thinning herds, and the sensible reasons for doing it. I'm a clinical psychologist and I know the probability of getting even grudging acceptance from those people to thin the herd is quite low. Killing animals and how brings up religious, spiritual, and ethnic issues. We gave achieved diversity in A2; that makes it almost a given that we cannot agree on this topic.

Nonetheless, it seems we need to discuss this problem. The problems I have raised in this letter are meant to be suggestive and informational. I don't have any answers. So I very much thank all of you for plunging into this morass. You are brave.
