Resolution for Community Events Fund Disbursements from the FY 2014 Budget

Whereas, The Ann Arbor City Council wishes to support activities that promote or bring the community together in its richness;

Whereas, The Committee recommends the following allocations:

- 4) A2 Ole School Family Productions \$750.00 to cover city costs for the 4th Annual Summer Picnic held on July 13, 2013;
- 5) Ann Arbor Convention & Visitors Bureau \$750 to cover city costs for the NJATC Block Party Event on July 31, 2013;
- 6) Ann Arbor Convention & Visitors Bureau \$750 to cover city costs for the UA Block Party Event on August 12, 2013;
- 7) Ann Arbor Council for Traditional Music and Dance \$578 to cover city costs for the Dancing in the Streets Event on September 1, 2013;
