Councilman Kunselman To Challenge Recall Effort at the Ballot Box

Earlier this month, recall petition language submitted by supporters of establishing homeless camps in Ann Arbor was approved against Councilman Stephen Kunselman, Ward 3 (D). Understanding that the recall effort is in response to Councilman Kunselman's publically stated opposition to the establishment of homeless camps in Ann Arbor, as homeless camps are dangerous, unsanitary, illegal, and unnecessary given the high quality of homeless services available to the homeless to live safely and legally in Ann Arbor, Councilman Kunselman will not appeal the approval of the recall petition language, but instead use this opportunity to engage the voters of Ward 3 by challenging the recall effort at the ballot box.

"My position on homeless camps is no different than that of Mayor Mike Duggan of Detroit, who just last week successfully led the effort to dismantle a homeless camp and find safe and legal shelter for all the homeless involved, all of whom were very grateful to have warm shelter. Homeless camps are dangerous, unsanitary, illegal, and unnecessary given the high quality of homeless services available to the homeless to live safely and legally in Ann Arbor. The dedicated homeless service providers of Ann Arbor and Washtenaw County, with generous financial assistance from the Ann Arbor City Council, the Washtenaw County Board of Commissioners, and every citizen who donates funding or volunteers their time and effort, have ensured there is capacity in the homeless shelter system for every homeless person to have safe, sanitary, dry, and warm shelter from the harsh, and dangerous Michigan winter – there is no valid excuse for any homeless person to live illegally outside in Ann Arbor and risk death from hypothermia or loss of limb from frostbite."

To counter the misinformation generated by homeless camp supporters, Councilman Kunselman will place on the agenda of the January 20, 2015 Ann Arbor City Council Meeting, a "Resolution Supporting the Establishment of Homeless Camps In Ann Arbor," in order to provide an open and transparent debate among the Mayor and Councilmembers about the dangers and illegality of homeless camps. While Councilman Kunselman fully intends to vote against the resolution, the public is encouraged to contact their elected representatives and voice their opinions on this very controversial issue.

REPORT: I was at 2700 S Industrial, headquarters for the AAATA, on 10-23-14. I was approached by Ron Copeland reference a passenger who has caused damage to the AAATA property.

BACKGROUND INFORMATION: I placed Aaron Grace in protective custody earlier in the month at the Blake Transit Center. There had been a court order to take Grace to U of M Hospital PES. The bus drivers witnessed Grace being taken into protective custody and they knew Grace as the man who had been damaging the bike racks on the front of the AAATA buses.

NARRATIVE: A driver, Richard, and Ron Copeland both approached me at AAATA headquarters about Aaron Grace and how he has been damaging bus property. Aaron Grace rides a bicycle to the bus stop and when he loads his bike to the front of the bus he has been causing damage.

Grace has been forcefully slamming the bus rack down and causing damage to the rack. Ron Copeland added that Grace has been aggressive with passengers and his anger is at a level of great concern. Copeland wanted Grace Trespassed/ Suspended from the AAATA buses and Blake Transit Center for 1 year.

TRESPASS: On 10-23-14, I heard Sgt Clock at the Command Desk state that YPD had arrested Grace and they were transporting him to the WC Jail.

I drove to the WC Jail and made contact with Sgt Ed Moorman of the WCSD. I explained to Moorman that I was there to read Trespass to Grace. Grace was at such a high level of anger that Moorman suggested that the Trespass notice be placed in Grace's property. Moorman did not want Grace to hurt himself out of anger and then have to enter the cell with Grace to administer medical attention.

ADDITIONAL: I made contact with Ron Copeland at 2700 S Industrial and gave him a copy of the Trespass notice and a picture of Grace. The AAATA will suspend Grace from riding the bus for 1 year.

REPORT: This report was taken via the front desk.

REPORTEE STATEMENT: Christine Hlavacek came into the station to report threats against her made from Aaron Grace. Hlavacek advised she stayed at the Staples Family Center on Packard some time in August,2014. Aaron Grace was there as well. Hlavacek advised on a Sunday afternoon, Grace chased her around the house and outside telling her he was going to kill her. Hlavacek advised Grace would yell "slut, dick sucker, I am going to kill you" while chasing her around. Hlavacek said " the police came but Grace was tried to get the jump and he was all polite so they didn't arrest him. Lucky for me, I left that day and played in a church band until 7 that night but when I got back to the house Aaron was sitting in the living room watching TV. I was just trying to get the last piece of lasagna and talking to my friend Jenny. I saw Aaron was still there and I said to my friend 'why is he still here and she was like I don't know'. Aaron yelled to me to shut up, he was going to kill me. I couldn't believe he was still here. I went around to everyone in the place asking them if they just heard what he said. Then, Aaron himself yelled 'yeah, I said I would kill you, what are you gonna do about it?' I called the police and they came back for a second time that day. I ended up leaving the center because they let him stay there."

Hlavacek advised she felt Grace had the potential to assault her since he had recently assaulted several people she knew. She advised she had seen Grace recently at the down town library and she felt Grace may have been "stalking" her. Hlavacek advised she believed Grace followed her into the library and was going to wait for her to leave so he could "assault or rape" her. She could not give specific reasoning other than he was assaultive toward other people and had made threats against her. Hlavacek advised, although Grace had not physically assaulted her in the past she felt with his aggressive nature it was only a matter of time before he did.

SUSPECT INFO: The suspect in this incident is Aaron Grace.

Novak also volunteers to help out with the homeless by giving them rides from 3501 Stone School Rd. (House of Hospitality) to the downtown Ann Arbor area.

On October 14, 2014 Novak drove to the House of Hospitality to pick up who she described as "an elderly couple" to provide them a ride. Novak said that while there, GRACE saw her outside by her car and started walking toward her yelling, "You fucking hoe, you fucking bitch! I'm gonna fuck you up!" Novak said that the people around her told her to hurry up, go inside and lock the door. Novak said she did just that. GRACE approached the home and attempted to gain entry. Unable to do so, GRACE commenced to kicking and pounding on the front door while yelling, "I'm gonna kill you!"

Novak said she stayed inside until GRACE left the area. She then left the area in her vehicle, providing the elderly couple their ride.

GRACE is angry as he was read his trespass rights from Novak's home.

NARRATIVE: I was at the BTC at bus stand 13/17 and I saw a subject matching Aaron Grace's description walk by. The subject was wearing a blue coat, black back pack, and he was pushing a bicycle. The subject was very angry and was directing a lot of anger toward a stranger at the bus stop.

I asked the man if he were Aaron Grace. The subject admitted that he was Aaron Grace. At the same time, a AAPD patrol car was driving by on S Fourth Ave. I thought it was Officer Spickard and I flagged the car down. Sgt Ouelette was driving the car and he got out and assisted me with taking Grace into Protective Custody.

CUSTODY/ TRANSPORT: I placed Grace in handcuffs and double locked them behind his back. Grace was placed in the back of my patrol car. Grace's bike and back pack were placed in the trunk of my patrol car.

I transported Grace to the U of M hospital without incident. Grace's bike and back pack were turned over to Stevem Oatten of the U of M Hositpat Security staff.

Preston Ross stated that he did not know the guy, but that Robert Harris referred to the guy as Aaron Grace. Preston Ross stated Aaron Grace was yelling and cussing "THESE MOTHER FUCKERS. FUCKING BITCHES." Preston Ross stated Aaron Grace was saying a lot of nasty things. Preston Ross stated Aaron Grace walked into the shelter; and he started to walk away from the shelter. Preston Ross stated that he was under the train bridge and he saw Aaron Grace was riding up on his left (saw over left shoulder). Preston Ross stated just after the bridge Aaron Grace rode his bike in front of me, threw his bike down, threw his back pack down, and put his arms out like this

Preston Ross stated that Aaron Grace said "WERE YOU TALKING SHIT MOTHER FUCKER? I AM A CRYPT AND A GANGSTER." Preston Ross stated Aaron Grace continued to talk shit to me; so I put my hands up in a non defensive manner and started to back away. Preston Ross stated Aaron Grace ran up on me/ charged me with his fists. Preston Ross stated I ducked my head down and Aaron Grace punched me in the head (right ear/just above the ear) with his right fist.

This officer questioned Preston Ross if the punch caused him to bleed? Loss of consciousness? Swelling? Did you need medical attention? Preston Ross stated No. This officer questioned Preston Ross when showered the next day and you put shampoo in your hair was the right side of your head and ear tender to the touch? Preston Ross stated No.

This officer questioned Preston Ross what did you do next? Preston Ross stated Aaron Grace ran over to his bike. Picked up his bike and his back pack and tried to ride it away. Officers were dispatched to 805 W. Huron (the Mercy House), reference a trouble with subject complaint involving a subject known to the caller as Aaron F. Grace.

INFORMATION:

The caller, described Grace to have come to the location, entering the residence uninvited and causing trouble. They described Grace to be a B/M wearing a Black Jacket, Blk Hat and Blk

Jeans riding on a blue bike.

Responding the area, officers observed Grace riding a bike along Third St. south from W. Huron. As officers were in a fully marked patrol car and waiting to turn off of Chapin St to W/B W. Huron, we watched as Grace was yelling as he was riding the bike. When he looked in our direction and observed the patrol car, he turned his bike around and began to ride back to W. Huron St. He then turned West on W. Huron, riding his bike all while yelling aloud.

Officers contacted Grace in the 500 blk of W. Huron, where Grace was verbally upset. He was yelling and stating that someone at 805 owed him money and had property of his. Grace was issued a trespass notice and released.

We then made contact with the residents of 805 W. Huron and spoke with a Sheri Wander. Wander was a resident of the Mercy House, which was owned by Peggy Lynch. Lynch who was not present, however she, along with Wander requested Grace be issued a trespass from the location due to his recent behavior towards other residents.

The house is operated by Camp-Take-Notice and assists the homeless with a place to stay. Grace had previously been allowed to stay for two nights. After that he was asked to leave. Grace began to return to the house recently and has begun to cause trouble trying to get a cell phone from another resident. At the time of this incident, he entered the house and made a threat to Wander. He then left prior to our arrival.

Wander was only able to stated that Grace was upset as he was attempting to obtain information from a cell phone that he had traded for the bike he had to an unknown male subject. That male subject who had the phone was older (not present) and unfamiliar according to Wander, with how to obtain the information which Grace wanted. This was upsetting Grace who thought the male was keeping the phone from him.

REPORT: Officers were dispatched to 805 W Huron in reference to a trespasser (see CR # 14-51395 / Trespass Info).

INFORMATION: Dispatch advised that the suspect had been threatening the residents at that location and was being very aggressive. The residents advised that the suspect's name was Aaron Grace who was wearing all black and was riding a bicycle in the area.

INITIAL SCENE: While en route, officers located the suspect on his bicycle in the area of W Huron St and Third St where they made contact with him. He was very confrontational with officers but complied with their request for identification, however, he did not answer many of their questions. He did state that someone owed him money at that location but did not go into detail about it. He was served with a trespass notice for 805 W Huron and was advised not to go back. He stated he would do what he needed to do. He was again advised not to return and he stated, "they will do what they need to do and I will do what I need to do". His identification was returned to him, he was given his copy of the trespass notice, and he rode away on his bicycle while speaking loudly and swearing. While officers were speaking with Grace dispatch advised that staff from the DeLonis Center wanted contact regarding an assault. Officers first made contact with residents at 805 W Huron and then proceeded to the DeLonis Center.

CONTACT WITH 805 W HURON: See CR # 14-51395 / Trespass Info. While officers spoke with the residents, Grace continually rode his bike in front of the house, on the road and/or the sidewalk, while speaking loudly and aggressively and was also swearing.

CONTACT WITH DELONIS CENTER: Officer then made contact with staff at the DeLonis Center who advised that Grace had assaulted a staff member, Bill McConnel, approximately 15 minutes prior.

VICTIM STATEMENT: McConnel stated that he was on the sidewalk in front of the shelter when Grace rode up on his bicycle and rode into McConnel three times and then proceeded to push McConnel. Grace then left the area. McConnel stated that he did not want to pursue anything criminally and that he (McConnnel) was not hurt.

VICTIM INJURIES: None received.

FORCE/WEAPON USED: The suspect used his hands to push the victim.

REPORTEE STATEMENT: The reportees, John Schippers, the Director of Programs and Operations for the DeLonis Center, and Ellen Schulmeister, the Executive Director for the DeLonis Center, stated that Grace has been causing a lot of problems at the center lately. Neither subject witnessed the assault on McConnel. They did advised that Grace has since been trespassed from the shelter two different times. The first day was 9-14-14 (see CR # 14-46066) and the second day was 9-18-14 (see CR # 14-46791). Since that time Grace has returned to the shelter three times:

- 1) 10-1-14: Grace was identified by front desk staff as being at the front desk.
- 2) 10-4-14: Grace picked up his identification and inquired about an upcoming meeting.
- 3) 10-13-14: Grace was invited to a meeting on 10-10-14 so that he could attempt to remove the trespass notice but he did not show up for the meeting. On today's date (10-13-14) he came to the shelter for the meeting but staff did not meet with him because of all the problems he has been causing.

WARRANT REQUEST: A warrant request was filled out by Officer Kleitsch requesting the charge of trespass for the trespass violations.

ADDITIONAL: Schippers provided officers with printouts of their incidents involving Grace as well as copies of the two trespass notices Grace had previously been served with. They have been included with this report.

Officers also requested extra patrols of the area of W Huron St.

SUSPECT ID: Staff can identify the suspect.

PROSECUTION DESIRED: McConnel does not want to press charges for the assault. Schippers and Schulmeister want to pursue criminal charges for trespass.

DISPO: Report filed.

I along with Officer Fouty was dispatched to the Ann Arbor District Library located at 3090 E. Eisenhower Pkwy for a Felonious Assault.

INFORMATION:

According to dispatch the caller and his brother were threatened by a b/m that was armed with a knife. The caller stated that the suspect approached them with a knife on Stone School near Pheasant Run. INITIAL SCENE:

Upon my arrival I observed both victims standing in front of the Library at the above location. VICTIM STATEMENT:

I spoke to Mr. Lester Harrington at the above location. He stated to me that he and his brother Mr. Kenneth Harrington were walking north on Stone School from their apartment on Partridge Trail. They were headed toward Michigan Ability partners located at 3810 Packard to pick up his check from the location. He told me that the suspect was riding a black mountain bike north on Stone School in front of them. Just south of Pheasant Run the suspect turned around and brandished a folding knife. The suspect then stated "You want to fucking start something". Mr. L. Harrington told the suspect no and stated the suspect then began riding north again. The suspect stopped again just north of Pheasant Run and pointed the knife at both victims stating: "You guys want to start some shit". Mr. L. Harrington stated he ignored the suspect and walked passed him, continuing north on Stone School. Mr. L. Harrington stated that he did not look back and did not know where the suspect went. He stated that he did not know the suspect and had never seen him before today.

VICTIM STATEMENT:

I Spoke to Mr. Kenneth Harrington at the above location. He stated that he and his brother were walking north on Stone School toward E. Eisenhower. The suspect was riding a mountain bike in front of them and stopped suddenly, got off the bike and turned toward Mr. K. Harrington and his brother. He stated that the suspect approached them near Stone School and Pheasant Run and pulled a knife from his pants pocket. He pointed it at them and stated "you two wanna fucking start something", the suspect then turned and resumed riding his bike north on Stone School. Mr. K. Harrington stated that just past Pheasant Run the suspect again dismounted his bike and began walking toward the victims while pointing the knife at them. Mr. K. Harrington was unsure what the suspect said the second time; he told me he just walked past him and called 911 on his cell phone. He stated that he did not know the suspect and had never seen him before.

REPORT:

This detective was contacted reference this case from the Director of the Bryant Community Center, located at 3 West Eden Court in Ann Arbor. The Director, Derrick Miller, contacted me reference this case indicating a possible Suspect in this case was a subject by the name of Aaron Grace, date of birth

Miller indicated to me the two Victims are involved in programs at the Bryant Community Center and that after discussing the case with them, Aaron Grace's name came up as a possible Suspect as Grace has been known to be in the neighborhood of Arbor Oaks area selling narcotics and has been problematic in that area. The two Victims are mentally disabled and are afraid of the Suspect.

This Detective completed a photo lineup of the Suspect in this case and made contact with the Victims and they agreed to meet me at the Bryce Community Center on that date. This Detective went to the Bryant Community Center and made contact with Melva Pressley who is a Case Worker for the two Victims. She advised that both of the Victims are slow but they believe that they would recognize the Suspect in this case if they saw him again.

PHOTO LINEUP:

This Detective met with Lester Harrington at the Bryant Community Center office. He was advised he was going to see a photo lineup of six photos. He was advised that the Suspect may or may not be in the photo lineup, that he should review the lineup and let me know if he recognizes anyone in the lineup. I advised him that just because he was seeing it, didn't necessarily mean that the Suspect in this case was in it. He reviewed the lineup until he reached photograph #5. Upon reaching photograph #5, he immediately recognized the Suspect in this case and identified him as the Suspect who had assaulted him. He stated, "That's him for sure, that's him." Photograph #5 should be noted is the Suspect, Aaron Grace.

CONTACT WITH KENNETH HARRINGTON:

This Detective made contact with Kenneth Harrington. I advised him that the Suspect in the case may or may not be in the photo lineup. Because he was reviewing the photo lineup, he should not feel obligated to pick anyone out, to just go through the lineup and advise me if he recognized anyone.

Kenneth went through the lineup up until he reached photograph #5. Upon reaching photograph #5, his eyes grew big and his hands began to shake. He then looked at photograph #6 and advised that he did not recognize anyone in the lineup. He was clearly, visibly upset when he reached photograph #5 which was the photograph number of Aaron Grace, but he did not admit to recognizing him.

Melva Pressley indicated that Kenneth was very scared to look at the photo lineup and is very scared of this individual.

FURTHER INFORMATION:

Detective received information that Aaron Grace has been causing multiple problems in multiple jurisdictions and at the Bellona Center/homeless shelter, and that a (unintelligible) had been placed for him. Aaron Grace was arrested on October 23, 2014 by the Ypsilanti Police Department.

REPORT: On 09/14/2014 Officer Kelso and I, Officer McCallum were dispatched to St Andrew's church located 306 N. Division regarding a fight in progress.

INITIAL SCENE: I arrived on scene and observed a black male (later identified as Aaron F Grace) and a white male (later identified as Robert Leroy Blankenship) verbally arguing with each other. Blankenship was sitting on the concrete stoop and Grace was standing approximately 12 feet north of him. Even with my presence both parties continued to yell at each other. I had to tell both subjects to stop yelling several times and I had to ask Grace to stand farther away to get both parties to stop yelling. Officer Kelso arrived on scene and made contact with Grace, while I spoke with Blankenship and a few witnesses.

VICTIM STATEMENT: Blankenship advised he came to St Andrews today for breakfast with his girlfriend, Henrietta Richards at approximately 0700 hours. Blankenship advised while inside the church he got into a verbal altercation with Grace. Blankenship stated he does not know Grace and didn't even know what the verbal altercation was about, he said Grace was yelling at him for no apparent reason. Blankenship along with Richards walked out of the church using the front door (west side of building). When Blankenship walked out Grace followed him outside. Blankenship said once he was outside Grace "Jumped him". Blankenship stated Grace punched him with a closed fist, striking him in the upper left side of his face (causing injury). Blankenship advised the punch Grace threw knocked him on the ground. Blankenship said he did not defend himself during the altercation. Once he got up from the ground Grace and him started exchanging words and yelling at each other.

VICTIM INJURIES: Blankenship received a cut on the upper left part of his face, causing Blankenship to bleed. Blankenship refused medical attention. Officer Kelso took a picture of Blankenship's injuries.

WITNESS STATEMENT: (Henraetta Richards) – Richards advised she accompanied her boyfriend, Blankenship to St Andrew's church for breakfast. While inside a black male (Grace) was very agitated for some unknown reason and kept verbally attacking Blankenship. Richards said Blankenship and her walked out of the church and were followed by Grace. Richards stated once outside Grace assaulted Blankenship by punching him in the face. After the assault she said she told one of the church staff members to call 911.

WITNESS STATEMENT: (Jennifer Jay Cole) – Cole advised she was outside of St Andrew's church (west side of the building). Cole observed Blankenship and Richards walk out of the church using the front doors. Cole said an unknown black male (Grace) followed Blankenship and Richards outside. Cole stated she witnesses Grace punch Blankenship in the face, knocking Blankenship to the ground. Cole advised after the incident both parties separated but started verbally arguing with each other.

WITNESS STATEMENT: (Matthew James Marsh) – Marsh identified himself as the Sexton of the church as well as the person who called 911. Marsh advised he didn't observe the entire

incident. Marsh did inform me however, that he observed Grace attack Blankenship outside the front doors of the church. Marsh advised he wanted Grace, Blankenship and Richards trespassed from St Andrew's Church.

FORCE / WEAPON USED: Personal Weapons (Hands)

SUSPECT: Aaron F Grace

ARREST/TRANSPORT: After hearing the victim and the witness's statements I placed Grace under arrest for simple assault, handcuffing him behind his back (tension check, double locked). Grace at this pointe was very agitated and said a multitude of insults to myself, Officer Kelso and Blankenship. Grace advised the only reason I was arresting him was because he was black. I have had a recent contact with Grace before and advised him I have always treated him with respect and that I was arresting him from what the witnesses observed. After my statement Grace calmed down. Officer Kelso transported Grace Ann Arbor PD without incident. Once at Ann Arbor PD I took Grace's photograph and fingerprinted him.

SUSPECT INJURIES: Grace complained of a hurt left hand, near his thumb.

REPORT:

On the above date and time, I Officer Kelso, was dispatched to St. Andrews Church at 306 N. Division reference a fight in progress.

INITIAL SCENE:

Upon arrival, Officer McCallum was already on scene outside the church, and had the two parties involved separated. I spoke with the suspect in this matter, while Officer McCallum spoke with the victim, ROBERT BLANKENSHIP. The suspect identified himself as AARON GRACE.

SUSPECT STATEMENT:

GRACE advised he just got into an altercation with a person outside the church. GRACE pointed out the subject he was in an altercation with, who was standing and speaking with Officer McCallum. GRACE did not know the subject by first name, but recognized him from an incident in which he was in with him at the Delonis Shelter yesterday.

GRACE was sitting at the breakfast table this morning minding his own business, when BLANKENSHIP came up behind him, and brushed up against him. GRACE advised BLANKENSHIP did this to him yesterday at the Delonis Shelter, and knew he was intentionally trying to start something with him. BLANKENSHIP sat down a couple tables down from him with his girlfriend, and started staring and talking shit about him.

GRACE got up from the table and walked out the exit doors of the church towards Division St. BLANKENSHIP followed him outside, and began talking shit again to him. BLANKENSHIP began threatening him that he would hit him with his carry bag that had a brick in it. BLANKENSHIP kicked at him, and GRACE caught his foot and pushed him to the ground. BLANKENSHIP got back up and kicked at him several times in the legs and on his right arm.

GRACE did not ever see a brick in the bag and was only threatened with it. GRACE also did not believe he was hit with the bag. GRACE said he separated himself from BLANKENSHIP, and called the police with his cell phone.

GRACE advised he did not need any medical attention as he was not really hurt that bad, but wanted to press charges against BLANKENSHIP for assaulting him.

for Lansing would not come again until tomorrow. John explained that the man then wanted to go to Lansing. The bus to Lansing comes once a day and had already come and gone at 1:20 pm.

The man quickly became upset and walked away from the window calling John "a bitch". John was surprised at how angry the man had become in such a short period of time. John called the AAPD.

AARON GRACE'S STATEMENT: Aaron was standing by a tree near the Greyhound bus window and waved me over when I arrived. Aaron said that he had just gotten off of the phone with Dispatch. Aaron said that if John can call the police then he can too.

Aaron said that he walked up to the window and wanted to know the bus schedule. Aaron said that John was "condescending, non-respectful, and not professional". Aaron said that John spoke to him with "racial hate tones and used a vibe that was disrespectful".

I asked Aaron to tell me exactly what John had said. Aaron said that he did not hear John and he didn't want to "put that on a man if he didn't hear it".

Aaron wanted a nuisance/disorderly person/ racial tones report written against John. I explained to Aaron that I would be writing a Information Report and he was not satisfied.

ADDITIONAL: John said that he was comfortable with Aaron staying at the Greyhound and riding a bus. John declined an escort to his car at a later time today.

Aaron said that he was not going to ride a bus and he was going to take care of his business. I drove by the Greyhound a short time later for a different incident and John made contact with me. John said that Aaron was still at the bus stop and he was bothering anyone. John was fine that Aaron was still in the area.
