### **Landfill Remedial Action Plan Update**

Patti McCall from Tetratech provided an overview of the Ann Arbor landfill and the Remedial Action Plan (RAP). Tetratech has been a consultant working on landfill monitoring and support since 2007. The RAP covers contingencies for monitoring and closure of the landfill, which does not currently accept waste.

- Hearing on Landfill Remedial Action Plan expected soon, as early as December or early 2015
- Landfill is located at the southwest corner of Platt and Ellsworth.

#### Discussion:

Naud and McCall responded to questions from the commissioners.

- If that state changed 1,4 dioxane standards, how would this affect the City?
  - Need to investigate further. Could lead to adjusting purge well 2 at the landfill. Most recent Remedial Action Plan was submitted in 2013.
- Does purge well 1 extend around purge well 3?
  - Yes. Are currently looking at pilot to reduce both 1,4 dioxane and vinyl chloride.

- How do purge wells work?
  - 6-inch wells placed 35 feet deep with pumps. They pump water in and send out discharge pipe.
     It's a constant practice. To deal with iron levels and build up, acid wells are placed triangularly formulation around purge wells. Two types of acid are injected to break up bacteria and clogs.
- Is the acid used in the pump safe?
  - Is safe. Acid is pumped to break up build up and then discharged to sanitary. Soil and gas sampling was done for a Park Advisory Commission analysis and no vinyl chlorides were found. No drinking water wells are in this area, and contaminants are in the water and not in the soil. Plan is compliant with state laws.
- What are the next steps for the Remedial Action Plan?
  - Currently getting citizen input and working on deed restrictions so that water is not used. Once finalized will have public hearing.
  - Constantly looking for ways to treat contaminants. Funded out of solid waste millage, so are constantly looking for ways to treat contaminants but also balance funding for other solid waste programs.

# **Ann Arbor Climate Partnership Update**

- City Council approved an \$85,000 contract to work with Clean Energy Coalition and the Ecology Center to further community-facing Climate Action Plan work
- Work will look at energy efficiency financing, outreach, and community solar
- Climate Action Plan was adopted in 2012 is available for download at <a href="www.a2energy.org/climate">www.a2energy.org/climate</a>

### Discussion:

- Aligns with the Sustainability Framework, which is a part of the City Master Plan
- Is Property Assessed Clean Energy (PACE) available for residential?
  - No PACE is only available for commercial buildings
  - o Ann Arbor was first city in Michigan to have a PACE program
  - First round of PACE was over \$500,000 in bonds to fund energy efficiency work
