Mr. Horning moved to discuss New Business "Workers' Compensation Insurance Renewal" first on the agenda. Mrs. Lumm seconded. The motion passed.

NEW BUSINESS

1. Workers' Compensation Insurance Renewal – Kelly Beck, the city's benefit supervisor and David Harlock from The Hylant Group discussed the proposed renewal for the City's workers' compensation insurance policy and third party administrator. The City has partnered with the Accident Fund Insurance Company for a number of years. The Accident Fund has decided to exit this industry segment in October 2015 so this was the last renewal offered by them. CompOne Administrators acts as the third party administrator for workers' compensation claims. Both the policy and the CompOne contract expire July 1st, 2015. Midwest Employers Causality Company was proposed as the City's new workers' comp carrier with a 2 year program. CompOne Administrators was proposed to continue as the third party administrator under a 3 year contract. CompOne's proposal contained 3 service fee options: fees based on percentage of annual payroll; flat, annual service fee; or a per claim service fee that included a minimum annual fee.

Mr. Horning move to approve Midwest Employers Causality Company as the city's new workers' compensation carrier for two years and to secure CompOne Administrators as TPA for three years; as well, the city will be selecting a percentage of payroll service fee option. Mrs. Lumm seconded and the motion passed.
