Dear Mayor Taylor and Council Members:

First, We want to highlight that we have been housing people since the Zero:2016 campaign began in January of this year. So far, a community effort including the WHA, OCED, PATH, Shelter Association, Ann Arbor Housing Commission, MISSION, HAWC and Avalon Housing Support Team and others have permanently housed 42 veterans and 35 chronically homeless individuals. In fact, members of our board [MISSION] are now in permanent housing as a result of these efforts. We are grateful that Council has put skin in the game for support services and infrastructure repair, and we're sure other resources we am leaving out here. We are also grateful to our all of our community collaborators, including all the council members who came out for Count Day and who have supported our wider community's efforts with votes that deliver concrete resources to the cause of better housing and better social services.

Also, we appreciate CM Briere sharing with you tonight this past weekend's Maiden Lane bridge clean-up project, where our team removing refuse from the camp sites that were shut down this spring. Sabra called Brian Durrance and mentioned to him that residents were asking about whether a cleanup is planned or not. After talking it over, for a day or so we came up with a plan to get this first site cleared. We are hatching a plan for another site that is closer to E. Medical Center Drive, in the near future.

Attached are some pictures of our team in action. As CM Briere mentioned tonight during her "Communications from Council" remarks, we [MISSION] are happy to help out, but our resources are minimal. As an organization, not only do we have operating costs, but also, we have a mortgage and we pay property taxes to the city. We hope, in the future, to collaborate directly with the city to help remove refuse from abandoned and current camp sites alike. If containers we placed at strategic locations, for example, we could have our team[s] fill them up the night before pickup. Let's please not forget that while we have been successful in housing many people, there are many more who are out there and who still need our support. We can and should continue to build a robust continuum-of-care that helps house as many people as we can, while reducing the harm to those relegated to living outside.

I think that is enough for now. I was going to share some thoughts re: the recent HUD Fair Housing rules SCOTUS ruling, but that is enough for now. We'll save that for another time:)



May 2015 Report

Zero: 2016 Initiative

In January 2015, Washtenaw County joined 74 other communities across the country when it launched its participation in the Zero:2016 Initiative, a national movement to end veteran and chronic homelessness by the end of 2016.

REACHING ZERO

Zero-Defined

The goal of Zero: 2016 is to end homelessness by reaching a "functional zero" count.

Functional zero is reached when, at any point in time, the number of people (veterans or chronic) experiencing sheltered and unsheltered homelessness will be no greater than the current monthly housing placement rate for that population (veterans or chronic).


Overall Goal


- House 153 homeless veterans by the end of 2015
- House 121 chronically homeless individuals by the end of 2016

Monthly Goal

In order to end veteran and chronic homelessness in Washtenaw County by the end of 2016 we must house—on average:

- 13 homeless veterans per month
- 5 chronically homeless individuals per month
