Kermit Schlansker, Saline resident, urged Council to be leaders in energy conservation.

2. Kathy Griswold - Improving Communication

Kathy Griswold, 3565 Fox Hunt, spoke about civic engagement and communication. She stated this includes more than just voting. She urged City staff to create a Council newsletter that all members can utilize. She urged the City to improve upon the A2FixIt system.

CC COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER WARPEHOSKI

Councilmember Warpehoski requested a status update regarding ADA improvements for the City Council Chamber. (City Administrator Powers responded that a status report would be coming to Council at the next Regular Session of Council, August 17.)

Councilmember Warpehoski spoke about the Arborview sewer issue, stating the sewer has a strong odor throughout the neighborhood, coming from the Scio Township line. He stated staff is working on the issue.

COUNCILMEMBER ANGLIN

Councilmember Anglin stated the issue with the Arborview sewer is unacceptable. He urged staff to address the issue and make it a priority.

COUNCILMEMBER BRIERE

Councilmember Briere reminded Council and the public that today is the 50-year anniversary of the Voting Rights Act and the 70-year anniversary of the bomb dropped on Hiroshima, Japan. (A moment of silence was observed in remembrance of those who lost their lives and the lives that were saved.)

COUNCILMEMBER LUMM

Councilmember Lumm thanked City staff for addressing the flashing lights at Washtenaw and Stadium. She stated this intersection is too dangerous to have flashing traffic lights.

COUNCILMEMBER GRAND

Councilmember Grand thanked the City Administrator for highlighting the upcoming activities at Gallup Park. She also noted that she will be out of town and not in attendance at the August 17 City Council meeting.

Councilmember Grand stated she is supporting the Administrator's recommendation regarding deer management and a deer cull. She stated in the future she would like to see a public and private partnership, and not the exclusive use of City dollars for management of the City's deer population.

COUNCILMEMBER KRAPOHL

Councilmember Krapohl reminded Council that he would be participating in a panel discussion at the Downtown Library on August 21 at 7:30 p.m. regarding his visit to Tuebingen, Germany.

COUNCILMEMBER KAILASAPATHY

Councilmember Kailasapathy stated she will also be absent from the August 17 City Council meeting. Councilmember Kailasapathy concurred regarding deer management, stating she too supports the Administrator's recommendation, noting that the current situation is not balanced and all species are affected, not just deer.

COUNCILMEMBER KUNSELMAN

Councilmember Kunselman stated he has long been an advocate against dangerous buildings and he thanked City staff for the effort to remove the burned building in his neighborhood on Springbrook.

A public hearing was continued from June 1 and June 15 on the proposed Resolution to Approve South Pond Village Site Plan and Development Agreement, 3850 East Huron River Drive. Notice of the continued public hearing was published on August 3, 2015.

Michael Homel, Woodcreek Homeowner's Association, 3473 Wooddale Court, spoke in support of the revised plan, stating concerns about access from Chalmers in the original plan and the use of Algebe Way for egress.

Eric Glenn, 1870 Meadowside Drive, spoke in support of the plan that moves the traffic to the north, urging Council not to allow the increased traffic onto Chalmers. He also asked City staff to place a sign on Washtenaw preventing the blocking of Chalmers Drive during rush hour.

Ethel Potts, Elder Boulevard, spoke in opposition to the plan and urged Council to deny, stating impacts to the environment as a concern.

Linda Plona, 1560 Woodcreek, spoke in support of the revised plan, urging Council to reroute the increased traffic from the development to the north.

James Bardwell spoke in opposition to the revised plan, noting the impacts to the sensitive environmental portion of the South Pond site. He stated over 1000 Michigan residents signed a petition in support of protecting this sensitive area.

Sarah Wesser, 4091 Thornoaks, expressed concerns about the increased traffic, including traffic on Huron River Drive.

Jenny Allan, 1485 Chalmers, thanked Council for listening to the residents' concerns about traffic and safety on Chalmers. She urged Council to support the revised plan, which does not require the paving of Chalmers for new wealthy neighbors.

Jean Mazzari, 1615 Meadowside, spoke in support of the new revised site plan, stating an access to the north is needed.

Raman Ranganathan, 1635 Meadowside, expressed concerns about increased traffic on Chalmers at Washtenaw, stating how congested it is currently at rush hour. He stated Chalmers and Woodcreek should not be utilized for access to this site.

Carole Bennett, 1575 Chalmers, expressed concerns about traffic on Chalmers and stated she would support the revised plan.

Nora Aziz, 1829 Meadowside, spoke in support of the revised plan and urged Council not to allow the use of Chalmers for access to the site.

Shirley White-Black, resident of Huron River Drive, questioned the traffic impact of the new plan to Huron River Drive. She suggested the site is not buildable and stated the new residents will not use Huron River Drive due to traffic.

A resident at 2091 Chalmers Drive spoke in support of the revised plan and stated the access point should be to the north off of Huron River Drive.

Amir Mortazawi, 1710 Woodcreek, stated the new compromise plan is the best proposal short of purchasing the land for park land.

John Megahan, 2050 Chalmers, spoke in support of the revised plan.
