## Action Item #1- Approve October 13 Agenda

**Bryan Kelly motioned** to dedicate at least \$6,600 to the Fairview, Dexter and Worden Ave project. **Edi Bletcher seconded**. Committee unanimously approved.

Committee would like staff to field check area to see if there are additional areas to plant trees.

## Discussion Item #1: Promotion of the Elizabeth Dean Fund

Robert Kellar, City of Ann Arbor Communications Specialist for Public Services attended the meeting to discuss promotion of the Elizabeth Dean Fund and the Committee. Mr. Kellar discussed free methods including, social media, CTN, resident newsletter, MLive, that can be used to promote the Fund and Committee.

Mr. Kellar suggested that the Committee determine immediate and long-term goals they would like to achieve through their promotion efforts. The following goals were discussed:

Long-term: Increase community awareness of the Elizabeth Dean Fund.

**Short-term**: Increase project proposal submissions by community.

Identify candidates to serve on Dean Fund Committee to fill vacancies.

#### Additional promotion ideas discussed:

- Develop a postcard to handout that includes information about the Dean Fund and ways to get involved in their activities (i.e. project ideas, serving on the Committee)
- Press release for project proposal submission and vacancies on Dean Fund Committee. Kerry Gray to draft and send out before November Committee meeting.
- Simplify project proposal to make it easier to apply for a project.
- Develop program to teach school age kids about trees. Need to identify contact with Ann Arbor Public Schools.

#### Discussion Item #2: Vesper Project

• Vesper Crabapple project FY15 budgeted \$3,600 for removal, replacement and pruning. Fund this project in FY16. **Motion by Mr. Muth** to approve FY15 Vesper Project in the same amount of \$3600. **Mr. Kelly seconded.** Unanimously approved by Committee.
