- TR-OT-15-02 South University Streetscape (E Univ. to Washtenaw)
  - Be it resolved: The Ann Arbor Public Art Commission recommends that the

South University Streetscape project (TR-OT-15-02) be enhanced because it is a both an important link and well traveled by residents, students and visitors. The enhancement should contribute to place making opportunities through the use of street furniture, wayfinding, sculptures, sidewalk embellishment, street embellishment or design elements determined by the task force. A budget of \$15,000 to \$45,000 is recommended. (Rizzolo-Brown / Smith)

Opportunity for the commission to begin at the design phase to embed and improve the streetscape visibility within the city. Joint City-DDA project. Planned for Summer of 2017. Commission will continue estimate the budget between 1-3% of the project costs.

- ∘ TR-AT-16-04 Non-Motorized Connection under E Medical Center Dr Along S Side of Fuller
- Be it resolved: The Ann Arbor Public Art Commission recommends that the Non-Motorized Connection at Fuller under the East Medical Center (TR-AT-16-04) should be enhanced to improve the experience and safety of its use. The enhancement should elevate the experience through creative and artful use of lighting, applied graphics, installations or other design elements as determined by the tack force. A budget of \$24,000 \$50,000 is recommended (Rizzolo-Brown/Smith)

Use tunnels, walkways, pathways to enhance Shelving units already installed along the Glen-Fuller over the tracks - along the border to border trail
