Alex DiLeo, City Planner, and Megan Masson-Minock, ENP and Associates, gave a presentation to Council and the Planning Commission regarding Downtown Premiums.

A two-tier approach to downtown premiums was presented.

Council and Planning Commissioners discussed the proposal, including developer premiums for residential projects, for affordable housing, environmental and energy savings, and building design.

A question was asked regarding alternatives to premiums to assist office development.

Councilmember Lumm inquired about best practices from other cities in regards to parking and premiums.

PUBLIC COMMENT - GENERAL (3 MINUTES EACH)

Ethel Potts, 1014 Elder, thanked Council and the Planning Commission for the discussion. She stated, based on the discussion, she thinks the Planning Commission needs to discuss the ordinance one more time before it is ready for Council. She also expressed concern about premiums being provided for residential development, unless it is for affordable housing. She also spoke about setbacks and open space.

Sean Havera, president of the South University Area Association, spoke about recent changes to the connection charges for water and sewer. He stated these charges, as well as the footing drain disconnection program fees, are making it difficult for developers to bring a project into the downtown. He urged Council to look at the fees.

Jim Chaconas of Colliers International stated his company manages about 70% of the commercial space in downtown Ann Arbor. He spoke about the cost of premiums and the square footage costs of doing business in downtown Ann Arbor.

Seeing no further business before the Council, Mayor Taylor declared the Work Session adjourned at 8:56 p.m.
