Re: Video Service Local Franchise Agreement for AT&T Michigan

Dear Ms. Beaudry:

This letter provides notice to the City of Ann Arbor, a Michigan municipal corporation (the "Franchising Entity"), and the Michigan Public Service Commission ("Commission"), that the Uniform Video Service Local Franchise Agreement ("Franchise Agreement") that was filed on August 24, 2016 by Michigan Bell Telephone Company doing business as AT&T Michigan ("AT&T") is now deemed approved. This is pursuant to Section 3(3) of the 2006 Public Act 480, MCL 484.3303 ("Act 480") and the January 30, 2007 Order ("Order") of the Commission, in Case No. U-15169 that states: "A Franchising Entity shall have 30 days after the submission date of a complete franchise agreement to approve the agreement. If the Franchising Entity does not notify the Provider regarding the completeness of the franchise agreement or approve the franchise agreement within the time periods required under this subsection, the franchise agreement shall be considered complete and the franchise agreement approved."

The 30 day period under Section 3(3) of Act 480 above for the Franchise Agreement expired on September 23, 2016. As a result, consistent with the Act 480 and the Commission's Order and instructions, Attachment 3 to the Franchise Agreement is being sent to both the Franchise Entity, and the Commission, as notice that the Franchise Agreement is considered complete and approved.

UNIFORM VIDEO SERVICE LOCAL FRANCHISE AGREEMENT (Form must be typed)

THE UNIFORM VIDEO SERVICE LOCAL FRANCHISE AGREEMENT ("Agreement") is considered completed and approved on this date December 2, 2016, pursuant to 2006 PA 480, Section 3(3) between City of Ann Arbor, a Michigan municipal corporation (the "Franchising Entity"), and Michigan Bell Telephone Company, a Michigan corporation doing business as AT&T Michigan.

Pursuant to Section 3(3) of the Act, "A Franchising Entity shall have 30 days after the submission date of a complete franchise agreement to approve the agreement. If the Franchising Entity does not notify the Provider regarding the completeness of the franchise agreement or approve the franchise agreement within the time periods required under this subsection, the franchise agreement shall be considered complete and the franchise agreement approved."

The Uniform Video Service Local Franchise Agreement was first filed on August 24, 2016, and has exceeded the 30 day submission date (pursuant to Section 3(3) of the Act) on September 23, 2016. Attachment 3 is being sent as a notification of a Franchise Agreement that is considered completed and approved to both **City of Ann Arbor**, a Michigan municipal corporation (the "Franchising Entity"), as well as the **Michigan Public Service Commission**.
